THE BRIDGEWATER FIRE.—The big fire noticed on Saturday evening, 22nd ult., was caused by the burning of the lumber and grist mills at the boundary line in Bridgewater, owned by Hon. G. W. Collins of that town. A dwelling house that stood near the mill, recently occupied by Ed Lane, was also burned. A very high wind prevailed at the time and it took only a few moments to reduce the mills to ashes. A quantity of sawed lumber was destroyed. A few years ago Mr. Collins rebuilt the mill and dam and put in considerable new and valuable machinery. His loss is about \$10,000, no insurance. It looked at one time as if the whole village would be destroyed. Stocks of goods and household furniture were taken from the buildings and quite a loss occurred that way. The night was a wild frosty one, but a large crew of men soon gathered there and a desperate fight was made to save other buildings, which was accomplished only after a hard struggle.
