### Oppressor and Oppressed.

The following peculiar case, showing how the poor are oppressed in some of our great industrial establishments is reported from Toronto. Fortunately it has an ending in which the hard hearted employer came out second best; At the Civil Assizes, before Judge MacMahon yesterday, the morning sitting was occupied with the suit of Mrs. Mary Townsend of 77 McKenzie-avenue against William Carter, a tailoring contractor doing business at 50 Bay-street. The plaintiff is a poor woman with an invalid husband and seven children. Carter made a contract with her to make two dozen pairs of overalls at 75 cents per dozen. Out of this she had to pay Carter two cents a spool for the thread used. By working nine hours a day she could contrive to earn a little less than \$1.50 in two weeks. She was a longer time than usual finishing the job, because one of her little ones was ill through lack of proper nourishment and required considerable attention. At last, one day she had completed the task, but it was late in the evening before she could get down town to deliver the parcel and get the \$1.50 she had toiled so long to earn. Carter's place was closed; she had no car fare and was too worn out to carry the parcel all the way home, so she took it to the home of a friend, Mrs. Vanderloof, on Sydenham street, to leave it for the night, intending to deliver it next day.

She had to go home to her children without the money she had expected that night, but next day one more woe was added to the already overladen woman, when Carter had her arrested for attempting to steal the goods. The police magistrate promptly acquitted her. She then brought suit against Carter for damages to her character by malicious prosecution. Messrs. Heyd & Elliott appeared for her, and the sweater, Carter, was represented by Mr. Allen Cassels. She had previously asked Mr. Carter to make a written apology to her, as the police court proceeding had damaged her chances of getting work. He would not do so at first, but finally two weeks ago, secured a clerical negotiator, Rev. Mr. Paul, to make a settlement with her. Paul got her a written apology and gave her \$10 from Carter, on condition that she drop legal proceedings.

The apology was refused and the \$10 returned next day. Mr. Heyd alleged fraud and misrepresentation in securing the settlement.

After hearing the evidence, His Lordship suggested that the case be settled out of court. After some negotiation, the case was settled in a manner satisfactory to the plaintiff, the sweater, Carter, securing the stipulation that the terms of settlement be kept secret and merely registered as "settled without costs."
