The Political Crisis.

The Liberals have a habit of finding constitutional obstacles to courses of procedure which they do not like, many of which are unsubstantial. They have no end of constitutional reasons just now why Sir Charles Tupper should not be asked to form a ministry. They argue that Sir Charles Tupper is a civil servant, and cannot therefore be called on; that he has not a seat in parliament, and chosen by a caucus of the Conservatives as their leader the Governor-General should not take heed of what a caucus does; that his name is not likely to be suggested by Sir Mackenzie Bowell to the Governor-General, as the Governor-General is not bound to ask the advice of his retiring adviser, and so forth and so on. The conclusion of the argument always is, of course, that the only proper and right thing for the Governor-dealers.

does, for all that, act upon it. When Sir John Macdonald retired he advised the Governor-General to call in Mr. Mackenzie; when Sir John Abbott retired he advised hin to call in Sir John Thompson. In each case the retiring premier advised the Governor-General to call in the man who he thought was best capable of commanding the majority in parliament or in the country. That, in fact, is the prime object, whether of the Governor-General or the retiring premier, and it is worth a view to reaching it that the Govenor-General seeks the advice of outgoing premiers, who are in the possition to understand the political situation better than anyone else. If the man who in the opinion of the Governor-General or the out: going premier commands the confidence of parliament or the people is a judge or a civil servant, or if he is not a member of parliament, so long as he is not disqualified from citizenship or of becoming a member of parliament eventually, he is quite qualified to be called in by the Governor-General, whether by or against the advice of the outgoing premier. Sir Oliver Mowat was called and was appointed before he had obtained a a seat in the Assembly. If the Governor-General chooses, therefore, whether by or against the advice of Sir Mackenzie Bowell, he can quite constitutionally and even rightly, if he believes it to be right, call on Sir Charles Tupper to form a ministry. If Sir Mackenzie Bowell retires we should expect that he would advise the Governor-General to call on him, if it appears that he is the choice of the dominant party in parliament. For if he is not called in when the parliamentary party in the majority want no one else, any other man chosen would find it impossible to form a ministry or to command the necessary majority in parliament, so that ultimately he would have to be called in. Of course, if the Governor-General believes, whether of his own knowledge or from the advice to the outgoing premier, that a man who possesses the confidence of a majority of a moribund parliament is not likely to secure the confidence of the country he will rightly pass over him and call in the man whom he believes to possess the confidence of the country, and by allowing him to dissolve parliament appeal to the people for a parliament to support him. This is not, how-

ever, as safe a course for a Governor-General as that of simply choosing the man who has the confidence of the majority in parliament as it exists. This man may be indicated by a vote of a caucus of the majority of members or by the suggestion of the well-known leaders of the majority, who would be willing to serve under him or in some other way, but, however indicated, is the probable choice. In any case, however, the final decision will be made by the country in the general elections, and the Opposition, however convinced should not therefore be called in; that if they may be that the game will be an unfair one, that dice will be loaded, should with dignity rely upon and await the verdict of the people.—Montreal Witness.

Atrocities are as natural to the Turk as the general elections to a parliamentarian. They are the traditional Ottoman method of renewing the mandate of the ruler. No doubt this is offensive to western civilization.
