OPEN SALOONS AND BRIBERY.

Prohibitory Law Denounced by a Port-

land Pastor. Rev. E.P. Woodward, pastor of the Second Advent Church, and one of the oldest clergymen in Portland, in a sermon recently vigorously denounced the state prohibitory liquor law as at present enforced in Portland "The Prohibition Farce" was his subject, and he dealt with it in a novel wav.

Pastor Woodward said that until a week ago he had believed the liquor law was being successfully enforced, but that belief was not the result of personal investigation. Being desirous of learning the true inwardness of the situation, he one day last week enlisted the aid of a local preacher who is familiar with work in the slums, and together they visited some of the rumshops of Portland.

They were not disguised, but made their tour in the role of tract distributers. Without effort they located 12 open rumships in the city, most of which they entered through the front doors. In a few instances in the poorer section they found the front entrances barred, but had no difficulty in gaining access by rear passageways.

vince him not only that Portland has open rumshops, but that bribery exists, and that in one way or another the proprietors of these bar-rooms are protected from molestation. In nearly every bar-room he visited there was evidence of permanent prosperity. counters, steel ceilings, a glittering array of bottles, glasses and other paraphernalia, and on the walls were hung advertisements of various brands of liquors

Four bar-rooms he looked in upon are in hotels, and he and his attendant found their way to them by inquiry at the hotel counters. He saw men drinking at the bar, others waiting for drinks which the barkeepers were mixing, and saw several men in a state of drunken stupidity.

At some of the rumshops the visiting clergymen were courteously treated, in others they were scoffed at and their tracts torn up, while in the best furnished places their presence seemed to awaken no interest among the men there assembled.

The speaker named some of the streets on which the saloons are located, but made no definite reference to their whereabouts. He said he could not positively swear what the bottles and glasses contained, but the odor about the place was precisely the same as the fumes emitted at the city liquor agency.

From interviews with prominent citizens conversant with the condition of affairs, the Rev. Mr Woodward said he was satisfied that the liquor dealers are making regular payments of hush money to somebody. The rumsellers seem to know just when the sheriffs are to make them a call, and when a seizure is made it is customary for the accused to carry his case to the farthest point at law, and during its postponement to make enough at selling liquor to pay his fine and leave him an ample income. The system in vogue is practically low license, except that the money goes into individual pockets instead of the City Hall treasury.

He declared that the clause of the prohibitory law making owners of buildings responsible for the selling of liquor therein has become a dead letter. The officers are not so much to blame for apathetic enforcement of the law, he said, for public sentiment does not compel them to live up to their oaths.


A Stepladder Went With The Match Safe. Do you see that that thing on the wall there? Above the clock? That thing with ribbons on it?"
