so located on the 8th day of October 1877 the day of the lease to Craig and others.

No answer.

(6) If so located on that date, was it so located for a period of twenty years or more, immediately next preceeding that date.

Ans.—No.

(7) If such public street or way was so located along, beside and past the English line, where was it located in reference to the English line on or before the 8th day of Oct. 1877.

Ans.—There was no public way.

(8) Did the owners of the fee of the lands under lease to defendants during the term the property was under lease, previous to the lease to Craig and others, have knowledge and notice of the way or thoroughfare through said premises and did they when they made the lease to Craig and others, intend to recognize such user, and concur thereto and confirm the right of the public to use the same.

Ans.—Yes.

(9) Did or did not the owners in fee intend by the plan inserted in the said lease to Craig and others, to define, and fix the location of said way as therein indicated.

Ans.—Yes.

(10) Did the covenant in the lease to Craig and others by the lessees (that is Craig and others) to keep open and unobstructed a public street or way have reference to the public way as indicated in and located on the plan in the lease?

Ans.—No.

(11) Did the defendants place or cause to be placed obstructions on the land to the south of and within 10 feet of English line as alleged.

Ans.—Yes.

(12) Did the plaintiffs in consequence of such obstruction sustain special injury and damage?

Ans.—No.

(13) If they had what damage do you think the plaintiffs are entitled to recover therefore?

No answer.

(14) Was George H. Connell one of the owners of the fee in and during the year 1874 of the lands now under lease to defendants, Moore.

Ans.—Yes.

(15) Did Geo. H. Connell in 1874 state at the time and under circumstances detailed by Leighton that there was a public road and that it ran along the English line.

Ans.—Yes.

Questions suggested by Mr. Gregory:

Was there a way leading from King street past the mill to the river in use at the time of the lease to Craig and others on the 8th of Oct. 1877, and, if so, where was it located in reference to the English line?

Ans.—There was, and about where it is now.

Did the owners of the fee of the lands now under lease to defendan., C. Miles Moore, dedicate a way over the same from King street past the mill to the river, to the public use, and if so, where was the way located in passing plaintiff's property, and what was the width of it?

Ans.—About where it is now, 10 feet wide.

Did the owners of the fee intend when they made the lease to Craig and others to recognize and concur in and confirm the right of the public to any way from the demised

premises past the plaintiff's property and if so what way?

Ans.—Yes! in accordance with the plan and lease.

Was there a concurrence of the owners of the fee and the lessees in dedicating any way to the public use, and if so where was such way located, in reference to the public line.

Ans.—There was no concurrence.

The judge proposed to change question (12) but Mr. Gregory objected that while a new question could be put, a question already answered could not be changed. His Honour then put in this question as 13½.

Assuming that the public way was located along, beside and past the English line, did the plaintiffs in consequence of such obstruction sustain special injury and damages, and if yes, what amount of damage.

Ans.—Yes, \$50.

The judge said that taking the case altogether he was quite convinced that the intention was to recognize a right of way along and beside the English line. The jury have found the lease referable to some other than the English plan. Taking the answer of the jury to question 7, that there was no public way and then giving the lease as referable to a roadway in the plan, the lessees would be estopped from saying that it is not where it is on the plan. With that view of the law, and with the answer of the jury, he said, he would enter a verdict for the plaintiffs on the second and third pleas, and assess the damages at the amount named reserving the right to enter for defendant, if his view of the law was over ruled. In the first counts, trespass and obstruction, he found for the defendants, in the plea, he found for the plaintiffs.

**Diocesan Missions.**

The Bishop of Fredericton has issued this letter to the Clergy and Laity of the Diocese of Fredericton.

FREDERICTON, Nov. 22.

My Dear Brethern,—In accordance with the resolutions passed at the Diocesan meetings in October I have (after consultation with the Board of home missions) appointed three Diocesan delegates to visit all the parishes of the Diocese in the interest of Diocesan Missions.

Archdeacon Neales will visit the parishes in the deaneries of Woodstock, Kington and Fredericton.

The secretary of the Synod (Rev. O. S. Newnam) will visit the deanery of St. John.

The Rev. H. Montgomery will visit the parishes in the deaneries of Shediac, Chatham and St. Andrews.

The delegates will themselves make arrangements for the meetings, which will be held as soon as possible.
