FOR MAYOR OF NEW YORK.

Henry George, the well-known reformer, whose work "Progress and Poverty," has, perhaps, done as much to influence thought on social problems, as any book of the latter half century, is a candidate for the mayoralty of "Greater New York." He is endorsed by Mr. Bryan and his friends and the papers say he will have a big vote. Among other planks in Mr. George's platform declared at a mass meeting are the following:-"We declare that the functions of street railway transportations, the lighting of the streets and homes of the people, whether by gas or electricity, the carriage of the people by ferries about the waterways of Greater New York, the facilitation of the interchange of speech by telephones or telegraphs are all purely municipal functions, things which can better be done by organized society than by individuals.

Deploring with full hearts the massacre at Hazleton, Pa., of a score of workingmen, who were shot down for exercising their natural rights to use the public highway for orderly procession, we call the attention of the people of New York to the fact that the execrable perversion of law by which that bloody deed was given a hollow resemblance to legality, exists equally in this city. We demand recognition of the right of the people to assemble peaceably, to use the streets for orderly passage in throngs as well as individually, and to speak as they will the political convictions which possess them.

And especially do we denounce the Interference with these rights by the mandatory order of a court, issued after an ex-parte hearing, and the disregard of which results in the denial of the citizen who has asserted historic rights of an opportunity to defend himself before a jury of his peers, whether excrcised by a federal or a state court; government by injunction is hateful, un-American and in flagrant violation of the principles of individual liberty, which our forefathers defended with their blood wherever despotism was combatted with the sword.

And, finally, we declare that this mass meeting was made necessary by the denial to the people of the right of self-government by men who have seized the machinery of the Democratic party organization, believed themselves able to dictate to the citizens of Greater New York, not only their rulers, but the very political questions with which they may occupy their thoughts. We are here to demonstrate that what Democrats shall or shall not think and speak is not to be determined on English race tracks nor in secret conclaves of self-constituted bosses."



Hunting For the Booty.

The finding of a revolver marked "Blood for Blood" has revived an old story of buried treasure at Phœnix, Ari., and a number of men are digging in the vicinity of the place where the weapon was found. In June, 1876, five men held up a stage coach on the Black Canyon road, near Arastia Hill. One passenger was killed and the booty consisted of a big roll of new \$100 greenbacks and a bar of gold worth \$32,000. A year or WOODSTOCK, N. deed throughout the entire Southwest, that the product of the stage robbery had been buried at Phœnix. Two of the robbers made partial confessions when mortally wounded, but their explanations were cut off by death. It seems that the robbers had feared to make use of the greenbacks, because those notes were rare in that part of the country and would arouse suspicion. They therefore buried the bills and cut the gold bar in two with an axe and buried half together with the pistol of the murdered passenger, which was a peculiar one bearing the words "Blood for Blood." The whole was inclosed in an iron coffee pot. Almost every year since the story of the treasure became known one or more searchers have appeared at Phoenix, each claiming to have a tip received at some "bad man's" deathbed or in some equally sensational way. Some years ago a priest from Magdalena Sonora, who had been given the lecation by a man who died of a wound received in a fight, spent a long time in searching for it without success. It is probable that the treasure, if ever buried at all, has been removed by some searcher who thought it well to conceal his success.


