

ACQUITTED.

The Jury Find Gullens and Graham Not Guilty.

County Court got through with its business on Thursday evening last. As reported in last issue the grand jury found true bill against Duncan Gullens and Israel Graham for assaulting and robbing Osborn Rodgers of Tay Creek, York county, although THE DISPATCH is informed that the jury came very nearly returning no bill. The trial occupied about all the time of the court. The complainant told the same story that he did at the examination before the police magistrate, and with which the readers of THE DISPATCH are familiar. We had a bottle of beer apiece for which Rogers paid. We talked a few minutes and drank again, drinking that way six or seven times. He called Mrs T. aside and they went into a room and got a bottle. I heard Rodgers tell Mrs. Tate that he ought to have it for 50 cents as he had spent \$10 or \$12 at her place. Finally Mrs. Tate said she would split the the difference. 
