From a Greek Archbishop to the English Prlmate.

In view of the interest in the Cretan ques tion, the following letter sent by the Archbishop of Patras and Elias to the Archbishop of Canterbury will be read with interest.

To His Grace the Archbishop of Canter-

Grace-Permit an Archbishop of the Hellenic Orthodox Church and Shepherd of the Secondary City of the Hellenic Kingdom to communiate by a fraternal epistle to Your Grace the Archbishop of Canterbury and Primate of the Anglican Christian Church the great pain and the deepest sorrow which possess my heart.

Most reverend sir, free Greece, small in extent, yet great in her historical beneficence to all mankind, by the wisdom and virtues of her ancestors, could not remain impassive and free from pain at the massacre of her Cretan children by their wild and bloodthirsty masters, a massacre which the entire press of the universe with astonish ment trumpeted forth. As an affectionate mother obeying the call and the wishes of her blood-stained daughter, Crete, seeking her union with Greece, with whom language, religion and nationality indivisibly connect her, she offered her a short time ago a helping hand, hoping to thus see fulfilled mutual wishes existing for ages. What could be more natural or more just?

Today long suffering Hellas stands astounded, as does the whole Christian world, in face of the terrible news that the united fleets of the civilized world, who waved the symbol of the cross, have discharged, their guns against the Christians who are struggling to regain their liberty! Once more the blood-reeking island is thus condemned to bow her neck and be delivered a slave in chains under the sword of the impious hand of barbarism!

Is their any sensitive heart which will not utter cries of pain and dismay at this news? That in Crete force and coercion and blockade is in execution by the Christian powers, the hands of warriors are tied who are struggling for the rights of man, for civilization, and

The Saviour of the world, God-man Jesus, sacrificed his life on the cross to free mankind from slavery and tyranny, and to transmit life, real liberty! Is it just that those who use the symbol of the holy cross on their flags Christian flags, should raise them high to protect the enemies of the cross, and to condemn the just efforts of free Greece for the liberation of her enslaved brethren? Terrible tidings!

By such sorrow possessed, I now make my fervent appeal to the well-known philanthropic and liberal sentiments of Your Grace. Yes, I come, beseeching the most Reverend Primate of the Anglican Church, so that in the name of the Redeemer of Mankind, Jesus Christ, in the name of philan. thropy and of Christian love, he raises his powerful voice from his exalted position to the mighty, and above all nations noted defender of all people's liberties, Britain, in support of our struggling Christian brothers

Such a voice from you, most reverend sir, can influence greatly for the good of the suffering Christians. This duty of Christian love is dictated, as you are well aware, to the leaders of the church by the spirit itself of the Holy Scriptures. History also bears testimony that the guides of the Christian Church, by the indication of Divine justice and by spiritual counsel, have succeeded in persuading the leaders of the state to be just and philanthropic to the people, and not to oppress the weak. As high above all these is the Highest King and Judge, dealing out justice and awarding to each according to his


The Cretans, bravely casting over the foreign scourge of their country, seek the help of all the laws of civilization and justice and if their cries, written in blood, are not heard, they appeal to the Tribunal of our Great God.

Convinced that my fraternal address, emanating from a soul in great distress, will meet with a graceful reception.

Women should learn to walk. The process is commonly supposed to come very early in life, but there are hundreds who can only stroll. Of course, for the woman who wears a No. 3 shoe on a 4 foot there is no hope, fortunately, so that she need not be taken into account at all.

To watch women who walk out on a bright day gives an idea of how vastly in need of practice in this art of walking most of them are. And it is an art-one, too, that pays, returning to its devotees value threefold in grace and color and appetite. If a girl thinks it stupid to walk briskly for an hour at least every day, this is no reason why she should not do it.

Let her fix a point two miles from home, and determine to reach it and get back within an hour. One arm may be allowed to swing in time to her step, which should be free and rather long than the least too short, but the other arm should be held at her side. This last is according to the long-established rule of training, which does away with excessive stiffness, at the same time preventing too much looseness of motion. She should breathe deeply and slowly, for that has much to do with the benefit derived from exercise, particularly in the open air.

If a girl resolutely determines to follow out such a practice, after a week's experience she will find herself not only thoroughly enjoying it, but missing it greatly if it must be given up for any reason.

But one reason should never be used as an excuse—that of the weather. Snow or rain or wind should make no difference. In the spring the warm, soft rains are more conducive to a clear, wholesome skin than are all the complexion preparations ever endorsed by the modern actress or the greatest beauties of past generations.

It should be always remembered that a woman who stays within doors all day does not use half the muscles of her body, and from want of exercise they soon become weak and out of order. To keep the general health vigorous and in a state of perpetual freshness nothing is so valuable as regular visits to the gymnasium. Though this is not always possible, the sensible woman will provide a good substitute at home, and keep to her exercises with strict regularity.
