The St. John Telegraph had a very interesting article recently on the trade carried on at Sand Point. It was suggested that "it would be a good plan to set apart a day and invite farmers and producers from all parts of the province to visit Sand Point and see the goods that are being sent away, as it might be a stimulus to them to try and provide simular goods and thus benefit the province and themselves."

"The Mantinea's cargo consists of the following: 31,150 bushels of mixed oats; 38,070 bushels of white oats, 30,000 bushels of clipped oats, 25,500 bushels of corn, 16,-950 bushels peas, making a total of about 141, 770 bushels, 1,000 bags of grape sugar, 4 bxs salmon lables, 10 cs cotton duff, 3 cs furs, 1 refrigerator, 133 bags clover seed, 6,260 bxs cheese, 650 sacks flour, 1,360 sacks asbestoes; 3 pkgs windmills, 1,004 sacks flour, 20 standard pine deals, 1 bx harness, 310 sacks seed, 78 bdls hay, 139 bdls pulp; 66 bags flour, 50 cs cheese, and 67 standard of spruce deals.'
