Fifty Years a Duke.

The Duke of Argyll, who has just celebrated the 50th anniversary of his succession to the dukedum, enjoys the well deserved reputation of being the most aggressive and quarrelsome man in the United Kingdom, and there is scarcely a person of any prominence, living or dead, contemporary to Queen Victoria with whom he has not at one time or another been in bitter conflict. He has quarrelled with the Queen, with his family, the leaders of both political parties, with the principal scientists of the day, and last, but not least, with the church, his attitude toward the latter being at one moment so hostile that on one memorable occasion the Bishop of Glasgow wrote a letter to the duke expressing his intention of refusing holy communion to his grace on the following Easter Sunday. The only similar act of episcopal severity toward a peer of the realm on record is the case of the present and Lady Shrewsburry and Talbot-the earl being the premier earl of the realm-who was refused holy communion at a country church in the County of Cheshire in consequence of orders received by the rector from the Bishop of Chester, who insisted that the elopement and divorce that had preceded the marriage of the earl and the countess were of a nature to debar them from receiving the sacraments. The Duke of Argyll has had a career that

has been almost as busy as that of Mr. Gladstone. He became an author at 19, chancellor of a great university at 28, a Cabinet Minister at 29. He has been three times Keeper of the Privy Seal of England, has been Secretary of State for India, and Postmaster-General, is Keeper of the Great Seal of Scotland and hereditary Master of the Queen's Household in Scotland, besides holding the title of "Admiral of the Western Isles." Moreover, he holds more nobiliary titles than any other Scotch nobleman. He is an artist of no small merit, a master of geology, ornithology and natural history, and so clever a scientist that Darwin considered it necessary to issue a volume of refutations of the duke's criticisms on his theory of descent. He is so imperious that the Scotch are convinced that he owns the earth, and one can well believe the story of the highland peasant who, when Princess Louise married the Marquis of Lorne, declared that "the through Hartland Village to Woodstock, and bounded as follows:—"Beginning on the western Queen must be a mighty proud woman to Callum More." He has been thrice married, dresses in a shocking manner, is exceedingly thrifty and has been known to dine off a dish of tripe, with six servants in his livery superintending this truly ducal repast.-Chicago

Stained Floors.

Stained floors should be restained at least once a year. Have the floor thoroughly scrubbed and dried before going over with the paint and varnish. To secure the best results the stain should be put on first and allowed to dry before the coating of varnish is added. A mixture of warm water, soap and household ammonia is the best fluid one can use for cleaning board floors. Never use a scrubbing brush on a painted, stained or varnished floor. Use a soft mop. Ink spots may be easily removed by rubbing them with spirits of salts, and grease will disappear after an application of fuller's earth.
