SUPREME COURT JUDGEMENTS .- The Supreme Court delivered a number of important judgments on Saturday, among them judgment in the fourteen Moncton Scott Act cases in which the jurisdiction of the convicting magistrate was questioned, on the ground that he was a ratepayer of the town into whose treasury the fines collected under the act are payable. The judgment of the court is (Hanington dissenting and Landry doubting) that the magistrate was not disqualified and the convictions in all the fourteen cases therefore stand. In two other Scott Act eases from Westmorland, ex parte Gallagher, rules were granted for certiorari to remove convictions on the ground that the magistrate at Sackville was disqualified because of a qui tam action pending against him at the suit of the defendant. Town of Grand Falls vs. Petit, judgment for plaintiff in action of ejectment sustained. Boyer vs. Boyer, judgment for plaintiff in the town of Woodstock civil court sustained, court holding, Vanwart dissenting, that a plaintiff may abandon to bring his claim within jurisdiction of court at the trial.
