

It is a serious mistake for a young man or young women to adopt a sarcastic manner, for it clings to them, at a time when they wish to be rid of it. I have known people to have such a reputation for satire and sarcasm, that every remark they made was thought to be influenced by this disposition. When they said "thank you" or "I'm greatly obliged," they were looked on with suspicion. The use of sarcasm may be a great gift, but it is a gift, which few who possess it, know how to appreciate. No one likes to be the victim of sarcasm. In public life, I believe that sarcasm is going, so to speak, out of fashion. Just as the good old days, when two men, disagreeing, took off their coats and started in to settle the matter with fists, is past, so is the day about past, when the tongue is used maliciously towards an opponent. This may be noted in reading over speeches by Sir Charles Tupper. He is, undoubtedly a master of sarcasm, yet one looks in vain, for the scathing references to political opponents, that characterized his public utterance of earlier years. Mr. McKenzie once told Dr. Tupper that he was one of those who, to quote Milton, "would rather reign in hell than serve in Heaven." When the doctor spoke in reply, he asked if the hon. member had ever known him to show an inclination to reign on the other side of the house. Sir Richard is sarcastic, but the happy change for him, has mellowed his temper and he is not as "terrible" as he used to be. His recent reference to liberalconservatives as polito-mulattoes, is not, by any means bad. The most sarcastic thing in public life of late years is Chamberlain's remark of Russia "He who sups with the devil must needs have a long spoon." It is said to have struck home, and may have more influence on China than anyone at

Fighting means more than singing patriotic songs, and waving flags. The trouble is that ceaseless parading of flags, and constant singing of patriotic, or more properly, of jingo songs leads to fighting, and the gallant wavers of flags, and the lusty singers of songs, are not always to be found, when the flame which they have industriously kindled, has burst forth into proportions which it requires bravery to subdue. Bellowing "fire, fire" may do at the beginning of a conflagration, but more practical work is required before the fire is subdued. Speaking of this rage tendency to wave flags and sing songs, an American Exchange says:- "We are intensely patriotic in the way of hanging out flags and in verbal demonstrations, but this is simply a species of self-laudation which is not of the least value to the American government or to the American people.
