#### Railway Collisio n.

On Wednesday morning last a terrible col lision occurred on the Pictou branch of the I. C. R. resulting in loss of life and great destruction to rolling stock. The train which takes miners to Westville left Stellarton, as is her custom, promptly on time-5.20 o'clock -in charge of Conductor W. W. Gordon, and he had with him James A. Sproule as engine driver, and J. Robert McKenzie as fireman, the train consisting of a locomotive and workingmen's car. A special left Picto for Stellarton to make connection with another special from New Glasgow with passengers en route as an excursion train for the Halifax exhibition. The Pictou special was in charge of Conductor Alex R. McLeod, with Michael O'Brien as engine driver and as fireman W. D. Henderson. The train consisted of a locomotive and four first class passenger cars.

On leaving Pictou there were over a dozen passengers on board, which number was considerably augmented at Westville. When within a mile of Stellerton, at a place called McAdam's Cut, in a very winding curve, one of the worst on the branch, in fact so bad that it is impossible to see twenty feet ahead, the two trains collided. Neither party could have seen the oncoming train and even if they did it was two late to put on brakes. The train with the passenger cars was going down grade and the locomotive with only one car up grade and both at a high rate of speed. The great engines crashed into one another and virtually telescoped each other. Both engineers and fireman met instant death at their posts. They were fearfully mangled, in fact so much so that they were almost beyond recognition. Two of them were in the debris and it was sometime before the bodies were recovered. The car next the locomotive, in which there were three passengers, reared up on the hind trucks, turned over and was a complete wreck. One passenger named Martin Cameron, from Scotch Hill, a young man bound to Boston, was killed outright. A number of other passengers were injured.

COUNTERFEIT nickles are in circulation. Both the old and the new styles of nickles are being duplicated in lead, one of those received bearing date of 1895, and the other having been used so long the date cannot be seen. Anybody can easily tell one of the counterfeits. In the first place their ring when dropped on a metallic substance is entirely different from that of a good nickle. A jackknife will readily whittle away a portion and the nickle can be used as a lead pencil. It is not known how many of the pieces are in circulation, but it would be well for all to keep their eyes open for them .-Star Herald Presque Isle.
