ACT RESPECTING BONUS.

An Act to authorize the Town of Woodstock, to take a vote of the property-holding ratepayers of said Town, on question whether such ratepayers approve the borrowing on Debentures, a sum not exceeding Fifty thou-Paper Mill.

Passed 28th April, 1899. Be it enacted by the Lieutenant-Governor and Legislative Assembly, as follows:-

1. The Town Council of the Town of Woodstock is hereby authorized and empowered, at any time after the passing of this Act, prior to the first day of December next, upon giving notice as hereinafter provided for, to submit to a vote of the property-hold-ing ratepayers of the said Town of Woodstock, the question as to whether or not the said ratepayers approve the borrowing on Debentures, at a rate of interest not to exceed four per centum per annum, any sum of money, not exceeding fifty thousand dollars, and giving the same by way of bonus to any Company, organizing and operating in said Town of Woodstock, a Pulp or Paper Mill, or both, which question shall be determined by a majority property vote of the said ratepayers voting at such time, who are assessed in the assessment list last filed, which said vote shall be registered by each of said ratepayers or agents, as hereinafter referred to, voting either for or against such question on the amount of real estate and personal property on which he or the estate represented by him shall have been assessed in the assessment list last filed as aforesaid: and the officer holding such election, shall keep a record of the amounts of property so voted upon both for and against the said question. In the event of a majority of the property thus voted upon being recorded in favor of the said question then for the purpose of raising money for the purposes of so invest-ing the same as aforesaid, the said Town of Woodstock is hereby empowered to issue, from time to time, certificates of indebtedness to be denominated on the face thereof "Woodstock Pulp Debentures," with coupons attached for interest, to be signed by the Mayor and countersigned by the Town Clerk, under the seal of the said Town, in such form, and in such amount, not exceeding the sum of fifty thousand dollars in the whole, payable at such place, in such sums, at such times, not exceeding twenty years from the issue thereof, and bearing such rate of interest (not exceeding four per centum per annum) payable semi-annually, as the said Town Council shall determine.

2. The said Town of Woodstock shall yearly and every year, after the issue of the first debenture hereunder, assess and levy pon the said Town, a sum sufficient to p the interest upon the said debentures by them so issued, and a further sum not less than four per cent. and not exceeding eight per cent. of the whole amount so issued hereunder, towards discharging the principal of said debentures, such assessment to be levied and collected in like manner as any other

Town Assessment. 3. All moneys assessed and collected for the purpose of a Sinking Fund under section 2 of this Act, shall until the same are required to pay off the principal of the said debentures from time to time, be deposited and kept at interest in some Savings Bank or Chartered Bank in the County of Carleton. and shall not be used for any purpose other than to pay off the principal of said deben-

4. The Town Council of said Town shall cause to be published by posters, and in the newspapers published in said Town, for at least thirty days previous to the taking of such vote, a notice of the time and place for taking the same, and shall make such arrangements, as to said Town Council may seem expedient for the proper taking of such

5. The property and estate of deceased persons, or held by trustees, may be voted upon by the Agent of such estates, npon such Agent making an affidavit, sworn to before a justice of Peace for the County of Carleton, or before a Commissioner for taking affidavits to be read in the Supreme Court, that he is the duly authorized Agent of such estates, and upon such affidavits being produced and filed with the presiding officers taking the said vote under this Act, the vote of such Agent shall be received, and the property of such estate so represented by such Agent, shall be recorded as having been voted upon, either for or against the said question, as may be declared by the said Agent. The provisions of this Section shall apply to the estate of the persons who have died since the last assessment, and whose names appear on the last assessment list of the said town, upon the said Agent making an affidavit of the decease of such persons for whom he claims the right to vote, and that he is the Agent of the estate of such de-ceased persons; which affidavit shall be sworn to and filed, as provided for in this Section. The officer presiding at and taking such vote, shall be sworn before a Justice of the Peace to the faithful performance of the duties of his office, previous to the taking of such vote.

6. Provided always that before the said bonus or any part thereof shall be paid to the said Company or individual, the said Company or individual shall have erected and completed all necessary buildings and machinery for the successful prosecution ot the said industry and the same shall actually be in operation, and the bonus then to be paid shall not exceed in amount ten per centum of the money actually invested in said buildings, plant, machinery and the lands, actually used in connection therwith, situate in said Town. twenty years. 9 Provided always, that should the said Company or Individual cease to provide for such insurance as aforesaid or discontinue the operation of said business for a longer period than one year, then the said Town Council may, on giving one month's previous notice in writing to the said Company or Individual or by publishing the same for one month in any newspaper published in the said Town of Woodstock, absolutely sell and dispose of the said lands machinery and premises or so much thereof, as shall be necessary to realize the amount of the said bonus, and retain the money so received therefor, to the use of the said Town to be applied towards the redemption of the debentures hereinbefore mentioned, and to convey to the respective purchaser or purchasers thereof, an absolute title to the respective portions which they may purchase; and in case the property so sold should produce an amount than would be necessary to pay the amount of said bonus, together with all cost and expences incurred in connection with such sale, such excess shall be paid over to the said Company or individual.

11. In case any debentures are issued by the Town Council purporting to be issued under authority of this Act, it shall be conclusively presumed it favor of the holder of every debenture, that the Town Counsil had had authority to issue snch debenture.
