Coun. Cronkhite-I have always thought the valuators as the best men and then report to the assessors if they like. Let the valuators take the valuation instead of the

Coun. Saunders-The law says the assessors must make the valuation. It was the duty of the valuators to see that the assessment was equal.

Coun. Gillmour-The idea of Simonds calling itself poor compared with Aberdeen. Simonds is the garden of the county.

Coun. Caldwell-If the law allowed us to pay the assessors a large percentage, and have them make a thorough assessment, which could be submitted to the valuators, it would be the better plan.

Coun. Lamont pointed out that parish assessment and county valuation were two dis-

Sec. Jones in answer said that the last

valuation was made in 1889. The motion was laid over for further consideration tomorrow.

The County Council resumed its sessions Wednesday morning.

The bill of Garden Bros. \$8.60 was ordered paid. Bill of J. C. Hartley, clerk of the circuit, \$58 24, paid. Dr. Curtis, chairman, submitted the estimate of expenses of the dist. board of health No. 10, under the provision of public health act, for Carleton Co., outside of the town, \$50 00. This was certified to by the chairman of the provincial

Coun. White said that it looked as if we were going blindly in this matter. It is on the judgment of one gentleman, Dr. Curcis, that this county placed in the estimates, a certain sum. Unless he can show some feasible reason he did not see why this should be

Coun. Saunders - The law requires it.

Coun. Cronkhite-The law says what we shall do, and it seems to me reasonable that the appropriation should be made. If the money is not used, no harm can be done.

Whereas the law relating to the election of members to the legislative Assembly of this province provides that the whole counties except the County of St. John, shall elect

And whereas it is advisable in the interest of pure elections, and the proper representation of the people that the province should be divided into ridings each to send one member to the Assembly, such a change would have the effect of selecting better men as representatives and would lessen the expense of elections.

Therefore, Resolved, that the Secretary Treasurer be required to prepare a petition to the local legislature asking to have the law amended so as to affect the purpose heretofore mentioned.

Mr. White said he did not expect such a law would be passed just to satisfy the County of Carleton, but he was sure it would be an excellent change. It was found most workable in Ontario. This county is particularly situated for this purpose. If we had three ridings he would divide them as follows:-The town and parish of Wooostock with Richmond and Northampton would make one riding, Brighton, Peel, Aberdeen and Kent would make another, Wakefield, Wilmot, Wicklow and Simonds would make another.

Coun Cheney seconded the motion. Coun. Mooers--Is the object to still have hree members?

Coun. White-Oh yes, only divide the county into ridings.

The motion was defeated, only the mover and seconder supporting it.

\$200 was ordered assessed for Wicklow for poor; \$175 for Aberdeen; \$450 for Brighton; \$100 for Simonds; \$300 for Peel; \$600 for half the material, cost proportionately less, Richmond; \$450 for Kent; \$300 for Wilmot. The various parish officers were approved

as named by councillors. Coun. Gilmour moved that all the statute labor for Aberdeen be in the hands of one commissioner, and that parish of Aberdeen be confined to one highway division.

Coun. Connoily seconded the motion. Coun. Gilmour said that he was asked that the statute labor be in the hands of the commissioner who had the road machine.

Coun. Lemont objected to the proposition totally. If you do this you give that one commissioner the power of the Czar of Russia. It might do if the road tax was paid in cash, but under the present conditions it would not work.

Coun. Gilmour said his idea was that the statute labor should be in the hands of the man who had the road machine.

Coun. Mooers-When you get a man who can run a road machine, you want to hang on to him. Why not engage this man to go wherever the work is being done.

Coun Forest-This council has already sanctioned the appointment of five commis

sioners for Aberdeen. Coun. Caldwell was against that resolution. To administer the road act was difficult, and certainly required the five commissioners. It would be very inconvenient in his parish to have such a change as Coun. Gilmour suggest-

Coun. Cronkhite said as there was a dis pute between the two councillors he must vote against the motion.

Sec-treas. Jones thought it would be well to get the legislature to so amend the act that the changes suggested by Coun. Gilmour, if approved, might be carried out. On a vote the following voted for the resolution Coun. Gilmour, Saunders, Richardson, Mooers. Lost.


