A letter received by Mr. Henry Chestnut dated at Dawson City, Nov. 19, states that Geo. E. Lawrence, who, with his father, W Harvey Lawrence, and his brother, Beverly, and two or three other York county men, went to the Klondike last April, died at the party's camp, of inflammation, during the second week of November. No letters have been received from any member of the Lawrence party since, and Mr. Chestnut in his letter states that up to the time of his writing none of them had received a letter from home, although many have been sent from here. Geo. Lawrence was a particularly shot, was discharged, the whole charge en rugged young man of about thirty years. He weighed over 220 pounds. His wife was in declining health when he left for the Yukon, and died only last week without knowledge of her husband's death.-Globe.


