#### Telegraph Line to Dawson City.

We have previously stated that work has been in progress toward the construction of a telegraph line from Skagway to Dawson City, in the Klondike region. The work has now been completed, the first message between than merely being it. the two points named having been sent on September 28. The part of the line now in operation extends from Skagway to Dawson City, a distance of a little more than 600 miles. Forty-one miles of this line is formed by the wire of the White Pass & Yukon Ry., from Skagway to Lake Bennet, and the regovernment. It is said that preparations are before it was recruited. being made to run a long-distance telephone line from Dawson City to points along the Yukon river, Circle City being one of the points which it is desired to reach ultimately. The nearest point to Skagway reached by telegraph is Cumberland or Comax, British Columbia. It is stated that arrangements will be made for steamers to call at Comax to deliver messages brought from Skagway and in any shape or form since. on their north-bound trips, for messages to be delivered at Skagway. 


