The following special rules for medal play will be observed:-The scores shall be kept by the competitors noting each others scores and the scores marked shall be checked at the finish of each hole. A Woodstock Edition. The Grip Sack, a St. John monthly devoted to trade and travel, devotes eight pages to Woodstock in its last issue. It contains an interior view of the stores of George W. Gibson and W. S. Skillen, an interior view of Dr. Manzer's operating room, pictures of Charles G. Connell's houses on Chapel St., Balmain Bros. warerooms and offices on Connell St., the Maritime Wrapper Factory, and two general views of the town. Among other things Grip Sack says: - Woodstock is well fixed for newspapers. The Carleton Sentinel published here is, perhaps, the oldest paper in the province. The Press is not so old. THE DISPATCH is the newest paper in the field and is one of the brightest country weekly papers in the Maritime Provinces. It is owned and edited by Mr. Charles Appleby, Barrister-at Law. THE DISPATCH is not a political paper, it is a newspaper. It goes after the news, all the news, and it is after it all the time. A glance through its advertising columns proves that the merchants of Carleton County know a good advertising medium when they see one. THE DISPATCH has been in existence something over six years and during that time its business has been constantly increasing until today it has the largest circulation of any paper in the country. #### Injured in a Fight.

Bertram Graham, a young man nineteen years old is lying at home with a fractured skull, the result of a scrap in J. D. Dickinson & Son's tannery on Saturday afternoon. Graham and a couple of other hands John Durant and his son Walter had a row in which Frank Dickinson acted as peace maker settled. Afterwards Graham went into a dark room to hang up some leather when he was struck on the head from behind. The Durants are in jail awaiting an examination before the Police Magistrate which cannot be held until Graham is able to get out.

#### Case of Assault.

In the Police Court on Tuesday morning there came up the case of Moses Williams against Hamilton Leith, both of the Parish of Wicklow. Mr. Williams said that Mr. Leith had assaulted him while he was driving Leith's cattle out of his yard. Mr. Leith told a different story and while admitting that there was a little tussle said he did not hurt Williams. The police magistrate fined Leith one dollar and costs.

Ferry Boat Episode.—School Meeting.—Jas-Tucker Sick.

On Wednesday last the Hatheway ferry boat made its last trip for some time and many an indignant individual has returned from the ferry boat landings after being informed that the boat was not running. The cause of this unsatisfactory condition of things is that the wire is cut on the Wicklow side of the river and this is the second time within two years that this wire has been cut. so that between the dissatisfaction that has generally prevailed in the management of the ferry and the wire cutting we are a lot better off without that kind of a ferry. The circumstances which led up to the cutting of the wire last week, were, so the story goes, that Rupert Hutchison of Wicklow with a load of hay requested to be put across the river, this request was refused him for two days, when he at last gave up the attempt to get across, but before he left the Wicklow landing a terrific noise like an explosion was heard and the wire dropped into the river. Who did the deed will probably be settled by a jury. But in the meantime this place needs a ferry and somebody who would manage things right, so that if the wire was cut one day it would not take more than a month or so to mend it, and then go look for law afterwards.

On Saturday last School District No. 2, Bath, held its annual meeting, and the attendance was much larger than usual. The trustees reported that the educational and financial condition of the district was much better than it has been for years. Robert Squires was elected trustee, Thos. Bohan retiring. Dr. Commins was re-elected auditor, and Michael Bohan secretary to the trustees and discrict.

On Monday last the express from Presque Isle brought to Bath the body of Percy Green, which was taken to Canaan for burial. His death occurred in Aroostook County by accidentally shooting himself while partridge hunting. His mother's name was Kinney and she was a native of Canaan where the young man has many friends and relatives to mourn their loss.
