CENTREVILLE.

Empire Day duly observed in our school where recitations and songs were given by the children all having reference to the Empire and Canada. Patriotic speeches were made by Rev. Mr. Spargo, Rev. Mr. Calder, Trustees Clark, West and Scholey and followed by G. W. White and our former teacher Dr. Peppers. The singing of "God Save the Queen" by the people brought the meeting to a close.

May 24th at 5.30 a. m. the inhabitants of our town were awakened by the music of the band. At 9 o'clock people from the near places soon began to pour in and by 2 p. m. nearly 2000 had assembled. At 2 p. m. the parade started, proceeded down Broadway across Mill street up Main street around the block twice. First came the band followed by a large platform wagon drawn by four black horses on which were seated 37 white robed girls with patriotic sashes and waving flags who sang many patriotic songs alternate with the playing of the band. Elevated on a seat by herself was Miss Ella Spargo dressed to represent our Queen Victoria. This was followed by twelve small boys wearing military caps and carrying Union Jacks. Following the boys was a farm wagon with a number of darkeys giving the crudest music with tin horns. A box cart representing Free State capital drawn by a heifer came next. Kruger was driving, Steyn seated on the box and Oom Pauline seated behind. An Indian followed with a blanket and gun. On a small wagon drawn by one horse was a colored barber cutting hair and shaving with wooden razor and shears. Next came an animal in shape of a horse attached to a two-wheeled cart in which were seated a darkey and his wife with a squalling kid in her arms and two other kids in a back seat. Then came four young ladies riding bicycles, one dressed as gipsy queen, another in green and white with an arch representing shamrock, the other two were dressed in white with flowers and ribbon. Looking after and marshalling the various rigs was George F. Briggs mounted on horseback dressed in military apparel and nobly performed the work assigned him. A game of base ball was played between our locals, Bristol and Bridgewater. The ladies of the Episcopal church provided the crowd with an abundant tea and refreshments the net proceeds were \$165. Flags were draped across the streets and were flying from every building.

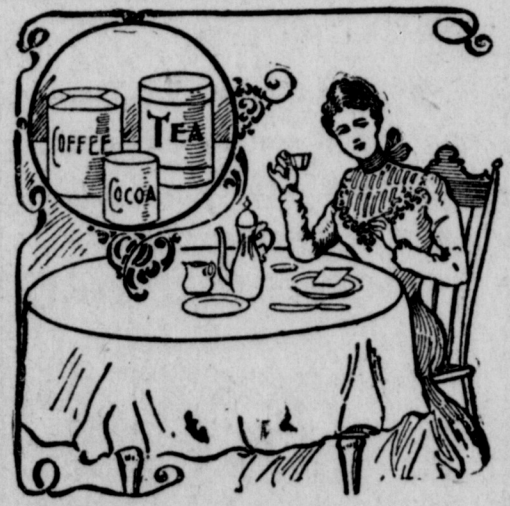
