Photography With a Fly's Eye.

Particulars of an interesting experiment are given in the German periodical Mutter Erde. The eye of the fly is of a composite nature, and consists of some 8,000 lenses; but each of these only forms an image of a point perpendicular to the facet constituting the lens. The pictures upon the retina of a fly therefore resemble a mosaic. As the facets are in different planes, and are of various sizes and shapes, they do not all correspond in focus, and it is thus possible for the fly to see objects at various distances, although its visual organs have no power of accommodation. It is no easy task to mount a fly's eye suitably for photographic purposes upon a metal plate without injuring its form or structure; but, after many failures, satisfactory results were secured. It was found that 20 centimetres between object and lens gave the sharpest results, and that the definition was more or less impaired at other distances; but negatives of bright objects, such as street lamps, the brilliant reflections of water, etc., were obtained up to a distance of 8 metres. To obviate the difficulties presented by the short extension of an ordinary camera and dark slides, a tubular camera about 1 metre in length, was tried; but the intensity of the image was so much reduced that three hours' exposure was necessary to obtain a passable negative.

No Pay For Electioneering.

ATLANTA, Ga., Aug. 5.—Can a man enter into a contract to do electioneering work on election day for a pecuniary consideration and legally recover from a responsible delinquent as in any ordinary commercial transaction? This is a question which may involve some points of law as well as morals. Justice Bateman says no.

The case of William Carr vs. Milk Blount involving the foregoing question, was tried before Justice Bateman. The testimony developed that the plaintiff had worked at the polls all day at the last Democratic primary election, under a contract made with the defendant, whereby the plaintiff was to receive \$10 as compensation for his labor, which consisted in distributing circulars in behalf of the tickets in whose election the defendant was interested.

Blount was running for deputy on the Fox sherifiship ticket. He paid Carr \$5 of the amount promised, saying he would pay the rest later. This he admitted when put on the witness stand. It was Carr's inability to collect the remaining \$5 that caused him to have recourse to the law.

Justice Bateman held for the defendant, not because there was any doubt, he said, of the debt being due the plaintiff under the agreement, but because he believed its nature was such that it could not be recovered. In delivering his verdict, the justice dwelt upor. the duty of every citizen to maintain the the purity of the electoral franchise, and said: "Such a contract is contrary to public policy, illegal and void, and judgment is
