give us about the same room as we have now. I would guarantee to do this work for \$500, and with the \$300 for water, it would only be \$800. \$1000 would make a fine gaol. To put a tank in, a room must be taken from me. The hall down stairs would make two more cells and we have not now a safe room in the house.

Coun. Cleff thought we had better adjourn and further consider this matter.

Coun. Forrest agreed with that proposition. He moved that we adjourn and meet tomorrow at nine o'clock.

This motion carried.

THURSDAY JAN. 11th.

The council meet at nine o'clock.

A communication from I. B. Curtis accepting the settlement re gaol matter was ordered placed on file.

Coun. Saunders moved that the council appoint a committee of three to visit the gaol and purpose to make repairs, the amount expended not to exceed \$1000.

Coun. Gillmore seconded the motion which carried.

Coun. Saunders brought up the question of A. B. Connell's bill, and moved that his bill be paid when it meets the approval of the auditor and finance committee. The motion was seconded by Coun. Atkinson.

Couns. Phillips (Brighton) and Cheney objected to paying Mr. Connell's bill without its being submitted to the council.

Coun. Phillips (Peel) agreed with the former speakers. If Mr. Connell was a poor man and needed the funds it might be different, but he thought Mr. Connell could wait.

Coun. Caldwell agreed with the motion. He was ready to leave the matter in the hands of the committee and the auditor.

Coun. Gillmore thought the bill should come before the board.

Coun. Carvell thought the same. He thought Mr. Connell might have found time to present his bill.

Coun. Atkinson thought those against the motion were voting want of confidence in the finance committee and auditor.

Coun. Bailey said that if he was asked to make out a bill he always found time to do so. He would not vote for the payment of a bill till he saw it.

The motion was lost.

The building committee are Foster, Carvell, D. Phillips, finance, Balmmain, Bell, (Wakefield), Saunders.

Coun. Phillips moved that a road record book be kept. Carried. List of the parish officers of Brighton was confirmed.

Coun. Richardson moved, seconded by Coun. Foster, that the Scott Act Inspector's salary be \$450 this year.

Coun. Atkinson moved, seconded by Coun. Caldwell, in amendment that the inspector's salary be \$360.

Coun. Lamont moved, seconded by Coun. Carvell, that the salary of the inspector remain as it was viz \$400.

Coun. Bailey said people at this council seemed afraid to discuss the Scott Act matter. I think he is paid well for all he has done. He has not stopped the sale of liquor. He simply collects enough to pay himself and a few others. They want to give him part of the surplus. He gets in all between \$700 and \$800.

Coun. Carvell thought Mr. Colpitts was satisfied with the present salary or he would throw up the job.

Coun. Caldwell thought the Scott Act Inspector had done a great deal of good up his way, but he had not treated us fairly in this matter. He utterly refused to tell us what his fees were, and we could infer that they were quite large.

Coun. Saunders stated that Mr. Colpitts had said that railway fares and other expenses took up all that he made in fees. He was going to vote for the \$400, amendment.

Coun. Gillmore said if you could get a hell on earth it was Glassville Corner a few years ago. Mr. Colpitts drove out the liquor from that place. He favored the original motion.

Coun. Atkinson was county councillor in Charlotte for 9 years. The highest salary paid the inspector there was \$360.

Coun. Phillips (Brighton) said a majority of the council is against temperance legislation only they were afraid to say so.

Coun. Bailey did not wish to reflect on anybody. He wished to say that he was in favor of the Scott Act.

Coun. Forrest said this board was no place for a temperance meeting. He did not believe in raising an officer's salary, when it was not asked for, but it was whispered around he would take it. He believed the sec. treasurer's salary should be raised before the inspector's.

The amendment to the smendment that the salary remain as it is was carried without a dissenting voice.

On the question of money for the Woodstock quota for the war, Coun. Saunders said he thought the town council should have acted at once, and not have waited for this council to act. He was heartily in favour of the council doing something for the boys who were going so bravely forward. He moved that a committee be appointed from this council to find out how many boys are going, and contribute a sum of—to insure the boys.

Coun. Caldwell thought we could raise a hundred dollars among the members of the council and give that at once. The body who go are worthy of the esteem and the love of their fellows. He was willing to start with a contribution of \$4.

Coun. Gillmore said all the people in the parish are willing to give by their country. They are going to insure us, and we should insure them.

Coun. Phillips (Brighton) thought we could get the money, that the legislation necessary would be forth coming.

Coun. Carvell favored asking for legislation, and also contributing individually. He believed in donating this day's pay as councillors to the boys. For his part he would donate all his pay this session.

Coun. Gillmore was the seconder of Coun. Saunders's motion.

Coun. Shaw—We have to have the money right away. I would place the council responsible as a body or individually for this money till the legislature gave the authority.

It was added to the resolution, that the sec. treas. be authorized to draw a cheque for the amount on order of the committee.

The motion was carried.

Those who did not vote were Couns. Caldwell, Tracey and Atkinson.

On account of Aberdeen's credit balance, and their large assessment for poor, \$90 be deducted from their share of the warrant for county purposes.

\$5.00 ordered paid to parish clerk of Woodstock.

Everett Harold asked for \$6.00 for three days hunting of a burglar, Davis.

The warden supported the claim which was ordered paid.

Moses Hovey, Brighton, tax, \$3.50 over assessment ordered refunded.

Coun. Cluff understood by auditor's report that we are \$6000 in debt, and we have that to meet in February. There is \$2400 due from town to county. Some steps should be taken to recover this amount. The sec. treas. should notify the mayor of Woodstock in the matter. A motion to this effect was passed.

Coun. Lamont moved that 6 per cent. be allowed to assessors of rates for county, and 2½ per cent. for schools, and 4 per cent. to collectors of rates of said parish. Carried.

Coun. Saunders raised the question of the county valuation. It was plain that such a rich parish as Aberdeen was not paying its share. He moved the valuers make their valuation as directed by law. This was seconded.

Coun. Lamont—The late sec. treas. said the valuation must be taken this year.

This was carried. After further routine matter the council adjourned.

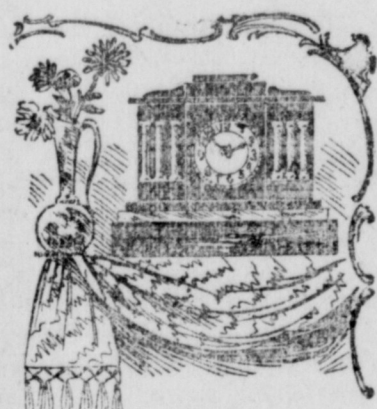

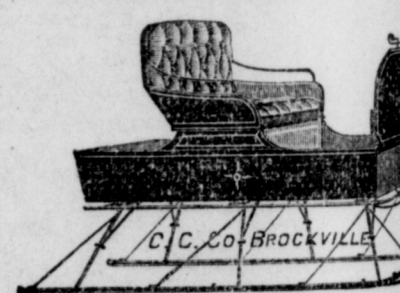
