A Unique Occasion.

It is not every man who, failing in business and making a compromise with his creditors, afterwards finds himself able to pay a hundred cents on the dollar of his old debt. Still fewer probably would be found willing to do so, even were they able. Yet this is exactly what Mr. E. F. R. Zoellner, of Mount Forest, Ontario, has done. Now he has kept his word; and to commemorate this event, rare in the history of Canada, last Wednesday evening at the Arlington Hotel, Toronto, he tendered a complimentary banquet to his old credicors and business friends. Among those present were, Hon. J. Gibson, Attorney-General for Ontario; Mr. T. C. Irving, of Bradstreets; Mr. Snyder and Mr. Shaw, of the Canadian Furniture Manufacturers, limited; Mr. Halstead, ex mayor of Mount Forest, etc. Many speeches were delivered on the occasion and many highly complimentary things said about Mr. Zoellner. We in common with all who know the circumstances of the case, congratulate the business community of Canada on having produced such a conspicuous example of the combination of the opportunity with the man .- Monetary Times.



Frances Hodgson Burnett was visiting in New England city, and her hostess, who did much home-missionary work, volunteered to take her to a home which was a shining example of what might be done on the most slender income by a woman who knew what good management meant. Who led the way to a wretched neighborhood. They stopped at a tiny tenement, which even outdoor showed the radiance of cleanliness. Mrs. Burnett's guide did not stop to knock; she walked in and led her guests unceremoniously through the few tidy, spotless rooms till they came to a kitchen, where a woman stood over a steaming washtub.

"This is one of the few model homes of the poor," explained the dispenser of charity; "the husband earns only seven dollars a week his wife makes a few extra dollars by washing, and there are five children to bring up on such an income. I discovered them in the dead winter, when work was not to be found, nearly starving and frozen. This class would almost rather die than take charity." Mrs. Burnett says as long as she lives she can never forget the flush of shame and helpless misery which reddened the face of the mistress of that humble tenement. THE FARMER'S HORSE.

For All Around Work the Clydesdale Is a Fine Animal.

The good draft horse is the one for the fermer to raise. There is no comparison between the drafter and the trotter as the farmer's horse. When the farmer can afford to keep trotters as well as drafters, all well and good, but the drafters he must have. The Clydesdale is at home at any kind of work on the farm-plowing or harrowing, seeding or gathering the grain, is quite in his element hauling heavy loads to market, always commands a ready sale, and if he is a few seconds longer in running to town than his trotting brother he gets there all the same. An authority on the subject says:

"It takes a larger and better horse to be a arafter now than it did some years ago. Good draft horses are all built on the same plan. They have size, width and quality, good constitution, and so on, but they differ marvelously for all that.

"Really high class drafters have a certain amount of range. The little, close to the ground chunk, the Dutchman's horse, so called, is not the horse to make a high class drafter. No one wants a leggy horse, but if the depth of rib and flank are right, if width, substance and quality are right, the horse that is far enough off the ground to move himself properly is the one to raise. He will have a prouder, more masculine carriage and set to the head, and his presence will be more impressive than if he approaches the deformed stage in his shortness of limb. The draft horse, the upstanding chap, is the one to buy.

Table Linen.

It is almost as essential that table and bed linen shall be properly hung out as that they shall be well washed. If they are allowed to dry out of shape, stretching and pulling them straight wears them much moro than use. Hang tablecloths and sheets evenly across the line, ends down. The warp threads are much stronger than the woof. If stretched habitually lengthwise, the things will split slong the fold. Indeed, everything washable lasts longer if hung to dry so that the weight while wet comes mainly on the long way threads.


