That Big Railway Project.

Mr. George McAvity was the medium through whom the New York capitalists secured from the Legislature in its closing hours the railway charters that are expected to connect New Brunswick and Nova Scotia with the railway enterprises of the Vander-bilts. Talking with the St. John Globe on Monday, Mr. McAvity said the plans of the promoters are at present all in the air. He does not look for any forward movement for two or three years, or until the plans of the syndicate are matured and all preparations have been made. Mr. McAvity is convinced, however, that if these people take up the assay, at fast line project, as now seems to be their intention, then a short line across New Brunswick will be built and a connection made with the Maine Central at or near Mattawamkeag. At present the whole project is in embryo and may never develop.

one for beginners and one for advanced work. Tuition and materials will be free to teachers from all parts of New Brunswick, but only a limited number can be accommodated. Forty can be admitted to the woodwork classes and twenty-five to the cardboard

The April term of the Victoria County Court opened at Andover, on Tuesday, the 15th inst., His Honor, Judge Stevens, presiding. The following gentlemen composed the petit jury:—C. Marshall Tibbitts, Elijah W. Sisson, E. H. Sisson, Rainsford Lovely, John H. Weaver, J. T. Curry, Jas. LeClair, Walter Warnick, J. F. Tweedale, Albert Brymer, Wm. Pirie and Columbus Craig. The following cases were before the Court, and were disposed of as follows:-

Henry Currie vs. Municipality of Victoria. Action of trespass on the case. T. J. Carter, plaintiff's attorney; Alex. Straton, attorney and A. B. Connell, counsel for defend ant. Mr. Connell challenged the array of jurors on the ground that the sheriff being a ratepayer of the county could not summon a jury, and that jurors being ratepayers and interested, were disqualified. Motion allowed and panel quashed. The venue must be changed in this case, and trial held in another

county. Mary Michaud vs. Baptiste Michaud. Action of assumpsit for use and occupation of lands. W. Fred Kertson, attorney and A. B. Connell counsel for plaintiff; J. J. Gallagher, attorney and counsel for defend ant. Mr. Gallagher moved to add pleas and demurrer. Motion granted, and trial of cause postponed until July term of Court.

Ordolf Hansen et al vs. James A. Patterson. Mr. Gallagher mover to enlarge rule nisi to set aside order under Woodmen's Lien Act 1894. Rule enlarged until July term. Thos. Lawson, defendant's attorney, consenting.

Johan Peter Jensen vs. Adam J. Beveridge, Abram E. Kupkey and W. Harry McAlary J. J. Gallagher moves to set aside inqu sition. Court considers.

Charles F. Watson vs. Peter Jensen. Action of replevin wherein one Johan Peter Jensen put in notice of claim to property. 
