Heavy Damages for Blain. (Toronto Globe.)

The jury in the Winter Assizes last eve ning awarded T. J. Blain, barrister, of Brampton, \$3,500 damages in his suit against the Canadian Pacific Railway. The hearing was finished about 5 o'clock, and the verdict was reported to the court three hours later.

Blain was a passenger on a special train from Toronto to Brampton on the evening of Oct. 10 last having been in the city to attend the demonstration in honor of the Duke and Duchess of Cornwall and York. On three different occasions on the trip home he was assaulted by Richard Anthony of Brampton, who seemed to have a grievance against him. The first took place at the Union Station here, the second shortly after the train passed Toronto Junction and the third near Streetsville. There was bad blood between the two men on account of a domestic trouble. After the first assault Blain drew the attention of the conductor of the train to Anthony's presence, and asked for protection. He repeated the request at Parkdale station, but there was no interference with Anthony on the part of any of the company's officials. Blain claimed unstated damages from the company because of their alleged negligence in failing to extend to him due protection while he was a passenger on one of their trains. He also claimed that he has been afflicted with deafness since he was assaulted, and that this was chiefly due to the blows on the head received from Anthony. The case has been in progress for a couple of days, before Chief Justice Falconbridge and a jury. Mr. W. R. Riddell, K. C., represented the plaintiff, and Mr. E. F. B. Johnston, K. C., the company. Many legal points arose during the trial, and each was thoroughly weighed. At the close of the plaintiff's case yesterday Mr. Johnston asked for a non-suit, on the ground that it had not been shown that the defendants knew of the reasonable probability of an assault upon Blain by Anthony, and also that if Blain had provoked the assault the company was not liable. The judge refused the motion, and gave a number of reasons, which were afterwards repeated during the charge to the jury

The jurors had been excluded from the court while the argument for and against a nonsuit was proceeding.

Mr. Johnston called no evidence for the defence, but some papers and documents had been put in as exhibits on the company's

Mr. Riddeli in his address to the jury said that the plaintiff asked for no stated sum in his original claim. The speaker believed, however, that \$10,000 might well be awarded to Blain. Of this \$5,000 would probably cover the disability on account of deafness, \$3,250 the loss of business, etc., on account of his enforced holiday, and the balance the other inconveniences which the plaintiff had suffered.

Chief Justice Falconbridge began his address to the jury by saying that the law regarding such cases had not been laid down, as one similar in all respects had never been tried in a court in the British dominions. The conductor, in the present instance, his Lordship said, had not seen the assaults on the plaintiff, but the company was liable if the giving of the notice of the probability of such assaults could be proven. Blain claimed that he had twice notified the conductor to that effect. The defendants were liable for any injuries received by one passenger from another when the conductor failed to discharge his duties. The facts were little in dispute, and the question was as to how far the conductor acted reasonably, having regard to the information which he possessed. It would be a very dangerous condition of affairs if the theory of the conductor that his liability arose only when he witnessed these assaults held good. The Chief Justice touchbriefly on the question of the amount of damages, if any, to be allowed, and concluded by saying that the case was of the very highest public importance.



"Father, here he is."


