A Menace to the Live Stock Trade.

The attention of live stock exporters, breeders and the press, is called to the case of H. F. Page, of Mission City, B. C., who was compelled to pay \$1000 duty on ten Percheron horses exported to the United States through the port of Sumas, Washington, in October, 1901. These horses were all accompanied by the proper registration papers of the American Percheron Horse Breeders Association, as required by the laws of the U. S. The contention of Collector Heustis was that, inasmuch as the animals were imported to be offered for sale they were subject to the duty. Mr. Page appealed the case, and the testimony was heard by Judge DeVries of the Board of Appraisers, whose headquarters are in New York. This board have the case under consideration, and will render their decision some time in August.

The action of Collector Heustis has been rather severely criticized by "The Ranch," a well-known agricultural paper of Seattle, Wash., to which journal he contributed the following defence of his action: "H. F. Page, the importer you mention, is an alien stock breeder residing in British Columbia. On October 18th, 1901, he imported at Sumas four stallions and six mares, making entry for same as pure bred stock, and claiming that they were entitled to free entry under the provision of article No. 475 of the existing tariff, which provides that any animals pure bred of a recognized breed, duly registered and certified as required by the regulations of the Hon. Secretary of the Treasury, shall be admitted free when imported specially for breeding purposes. Pedigree certificates were presented with the entry, but as the animals were evidently imported for sale, the importer was required to deposit the amount of duty that would accrue in case the animals were found not to be entitled to free entry, and was given an opportunity to produce satisfactory evidence that they were intended specially for breeding purposes, which said evidence was lacking on entry. Neither the deputy collector at Sumas nor this office questioned the genuineness of the registration papers as intimated in your editorial, and Mr. Page well knows that was not the reason that he was required to deposit the

duty. (note:—Mr. Page says, "He never was so informed.") It was purely a question of evidence on the point of the purpose for which the animals were imported. As you are aware, Percherons are valuable for draft horses, and when imported for that purpose are subject to duty, and a proper enforcement of the tariff, as well as regard for the protection of American stock raisers alike demand a full investigation of the facts."

It therefore appears that the whole matter depends on the official interpretation of the clause, "when imported for breeding purposes." According to Judge DeVries the question has never before been raised, although it is a well known fact that large numbers of pure bred cattle have been sent to the United States by Canadian breeders for sale at public auction and always as far as I have known, free of duty. If the contention of Collector Heustis is sustained, the decision will generally be regarded as a decided injustice, and contrary to the spirit of the law. It will cause a complete cessation of the trade in pure bred stock between this country and the United States; in fact it has already had that result as far as the trade between B. C. and Washington Territory is concerned. This is a matter of vital importance, not only to the Canadian breeders who have stock for sale, but to the Americans who have need of such stock for the improvement of their studs, herds and flocks. Immediate action should be taken by our Live Stock Associations and a strong protest entered against such unfair ruling. As the "Ranch" very pertinently says "It is well known that many firms make a business of importing from Canada and from the Old World pure bred stock of all kinds; and that such stock is permitted to pass in free, provided it is accompanied by the proper certificates of registration. The government does not follow such stock after it leaves the custom office, and the importer is free to dispose of this stock to any one he likes, and at whatever price he can get. If Collector Heustis is upheld in this contention that pure bred stock must be imported for breeding purposes only, and cannot be sold or worked, it will paralyze the whole business of importing horses and injure the trade in other lines. We think that the various Breeders' Associations should act on this case in order to bring properly before the board of appraisers the wide spread injury an adverse decision in the Page case would have on the whole breeding industry.

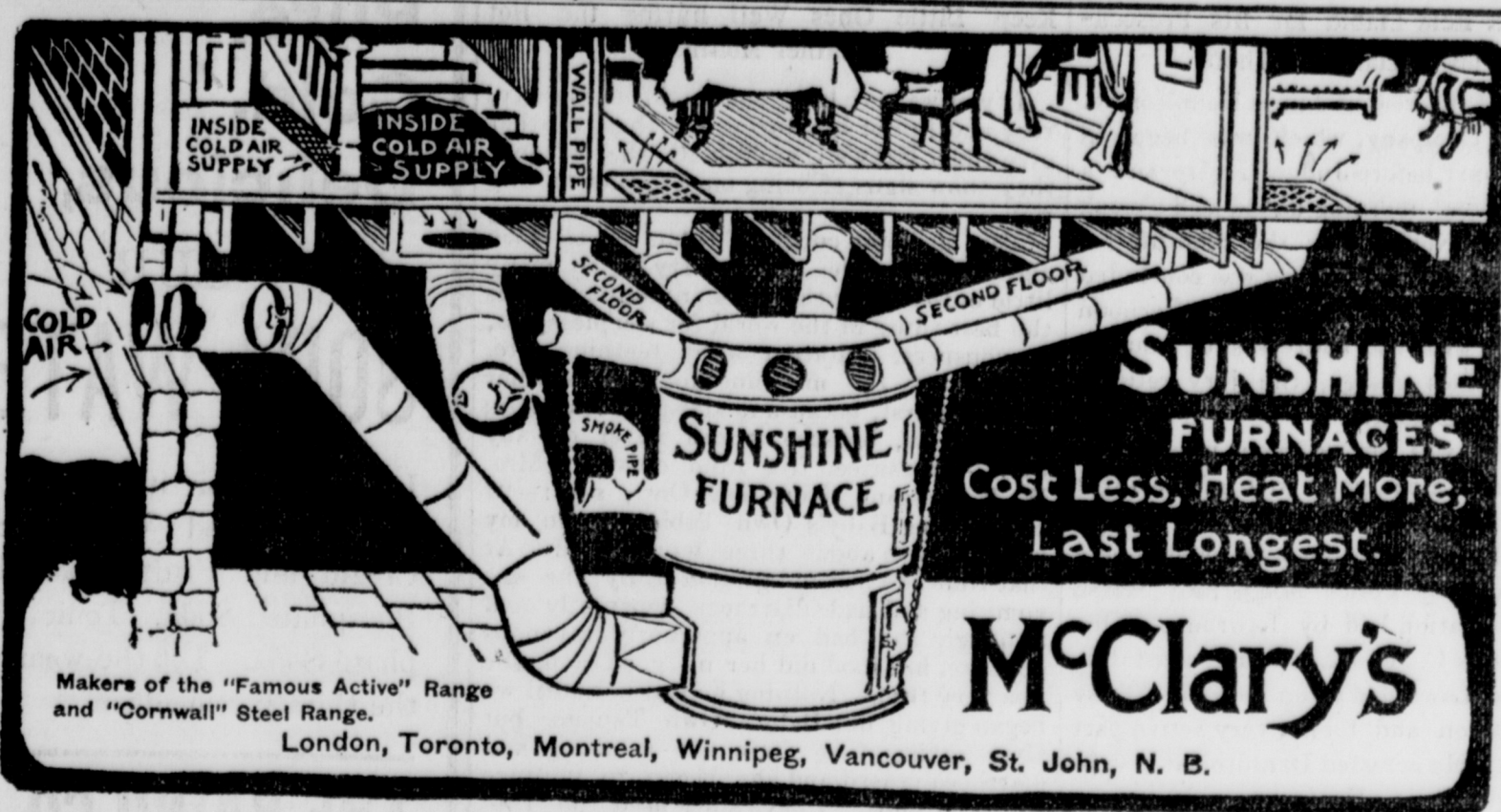

No doubt the recent cold weather we have been having has stimulated the consumption of butter. The prices of the Canadian product have advanced about 2s. per cwt. on the week, and "choicest" salt now brings 98s. to 100s., with saltless 2s. higher. generally by the Canadians is so inferior to that employed by the Australians and New Zealanders, the difference in cost being less than 1d. a box.

The market in Copenhagen continues firm, and the official quotation remains unchanged. Tinning operations are in full swing, and will last for two or three weeks longer. The general opinion is that prices for all European butters are at their lowest. American export is still impossible, owing to the high prices existing in the United States, and there does not seem to be any probability, therefore, of Canada being able to swamp our markets. For the last 13 weeks the total import of butter averages 266 tons per week in excess of the same period last year, and yet prices are not affected. This circumstance shows how deficient in quantity the home production has been this spring. The demand for Canadian cheese is good and arrivals go direct into consumption at about 50s. to 51s. per cwt. for "choicest." The amount of "finest," selling at less money, is almost infinitesimal. Old Canadian is very irregular in price, ranging from 53s. 66s. Old New Zealand is making 50s. to 5s. The amount of Canadian cheese which arrived in this country from the week ended May 3 to that ended June 14 inclusive is about 600 tons less than during the same period last year.—London Times.

ALFONDLY 0149.

Alfondly is a very handsome bay stallion, standing 16 hands high and weighing 1150 pounds. He was bred by L. H. Smith, of Arcanum, Ohio, in 1892. Alfondly has the kindest of dispositions, and in addition to his speed, he has characteristics which render him a particularly valuable "all-round" horse. No one could wish a more nearly perfect driving horse than Alfondly. His gait is the poetry of motion, and he is faster than any other horse for scores of miles around. He is also a great campaigner, and, as an illustration of his powers in this direction, we may cite a few instances from his work as a three-year-old. In his first race, on May 28, before fairly in condition, he came out second in 2:20. Out of the next eight races in which he took part, he won seven, six in straight heats, and in the other took the first heat, and was then drawn on account of an accident. On August 2, at Middletown, Indiana, he went up against a field of twelve competing horses. There he distanced, or caused to be drawn, five of the number, and won the race in straight heats, as usual. His crowning glory was his performance at Richmond, Indiana, on September 12, 1895, where he again carried all before him, lowering his record to the remarkable figure of 2:12. All these races took place over ordinary half-mile tracks. He has trailed a half-mile track in 2:07, which comes very near being as fast as any horse in the world ever paced such a track. In a six-year-old form he started ten times winning five firsts and never behind the money but once, and that was for not getting a heat in five, but he was second to Ada P. who got her mark of 2:09 in that race. Alfondly's sire was Petoskey, by George Wilkes, the world's most famous sire, with 23 in the 2:30 list. Alfondly is a double cross Blue Bull with 64 in the list. He will stand at the owner's stable, Centreville, from Friday noon to Wednesday noon, and will be at Woodstock at Gallagher Bros. stable every Thursday. 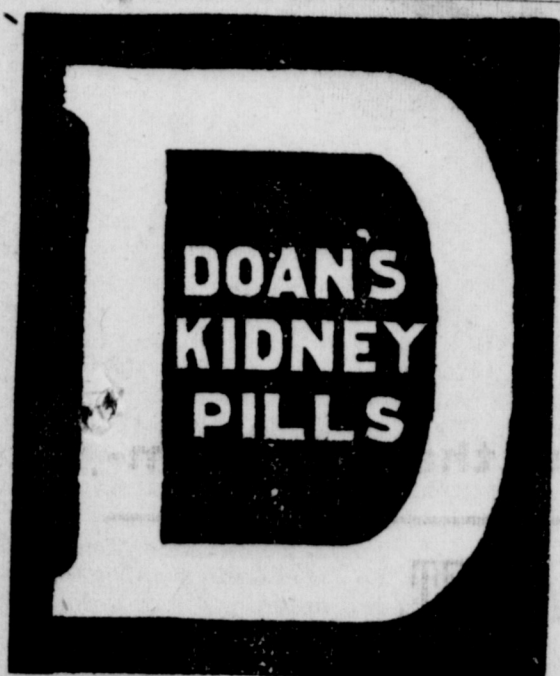
