DENNISON WINS HIS CASE.

The C. P. R. Held Liable for His Prosecution on a Charge of Theft.

The trial of the case of James Dennison vs. the C. P. R. Company, which was begun in the circuit court before Judge Landry and a jury Wednesday morning ended at 8 o'clock last night in a verdict for the plaintiff for \$200.00. The evidence-taking was concluded just before 1 o'clock and the whole afternoon was occupied with the addresses of counsel and the Judge's charge, the jury retiring It is just the medicine for hot weather shortly after 6 o'clock.

The action was for malicious prosecution of Dennison on a charge of theft of a revolver from one John Lawrence at Debec Junction in August last. Dennison was arrested on a warrant issued by Police Magistrate Marsh on an information laid by Lawrence. One W. R. Scott, a C. P. R. special constable, accompanied Lawrence when he went to lay the information and took a very active part in the case. He arrested Dennison at Hainsville, brought him to Fredericton, where he was met by two other C. P. R. detectives, L. G. Crevier and D. O'Regan, who gave directions to the magistrate concerning the case. The Police Magistrate remanded Dennison to jail to await a preliminary examination here next morning. The same night a telegram was received by Lawrence from Debec Junction saying not to arrest Dennison. Later on O'Regan reported to Police Magistrate Marsh that Lawrence was at Woodstock and the latter handed him an order to take Dennison to Woodstock for preliminary examination next morning. O'Regau did this and Police Magistrate Dibblee, of that town, heard the case and dismissed it. Crevier, O'Regan and Scott were all present and it was claimed employed Mr. A. B. Connell to appear as prosecuting counsel. On these facts plaintiff contended that the prosecution was the prosecution of the C. P. R. and the jury so found, after the Judge had refused a motion for a non-suit.

His Honor left several questions to the jury to answer with reference to the capacity in which Scott, O'Regan and Crevier were acting in the case, and to the matter of their being reasonable and probable cause for the prosecution. They found that the constables were acting as C. P. R. officers; that the prosecution at Woodstock was carried on at the instigation of Crevier and O'Regan; that Police Magistrate Marsh received instructions from them to send Dennison in custody to Woodstock: and that there was no reasonable and probable cause for Dennison's prosecution. After receiving the jury's findings His Honor explained that the question as to whether there was reasonable and probable cause for the prosecution, although he had left it to the jury, was really for him to decide as a matter of law, and that having heard the jury's unanimous finding, he would himself find that there was no reasonable and probable cause and direct a verdict to be entered for \$200.00, the amount to which the jury assessed the damages.

Influence of Names.

"We're going to name our newly arrived boy Reginald," remarked Phillips at the club the other evening.

"Do you want him to be that kind of person?" asked Jones, in a tone that he hoped would create discussion.

"What are you springing on us now?" asked several of the group, a little wearily.

"It is a great truth, my boy," continued Jones, aiming his remarks at Phillips, who looked a trifle worried about Jones' question. 
