The following is Mr. Colpitts report:-To the Warden and Councillors of the Municipality of the County of Carleton.

GENTLEMAN:-I have placed my account as Scott Act Inspector for the year 1902 in the hands of the County Auditor, by which it will appear that there is due me the sum of \$12.64.

During the year I had 49 Scott Act cases. Of those there were 19 convictions made, and 30 cases were dismissed.

During the year I paid into the hands of the Secretary-Treasurer the sum of \$921.00. Respectfully submitted,

assessment for the ensuing year stated that they considered \$9000 would be required and on motion of Coun Williams it was decided to assess for \$9000 with one quarter the indebtedness of each parish added.

Council adjourned till Wednesday at 10 o'clock in the morning. Wednesday, Jan. 14th.

Council came to order at 10 o'clock, after the reading of the minutes, the committee on the Scott Act reported as follows:-

To the Warden and gentlemen of the County

Council of Carleton, Gentleman,-We your committee beg leave to report that after very carefully going over the accounts of Inspector Colpites we find that many of the changes are not itemized and after questioning Mr. Colpitts with regard to the matter we therefore recommend the payment of the same and that hereinafter the Inspectors accounts must be fully itimized setting forth number of miles travelled by each and every officer and all expenses connected therewith and we further recommend that no counsel be employed where defense is not conducted by Counsel and also all detective work connected with the same.

E A SIMONDS, DAVID PHILLIPS, J H FORREST.

Coun Phillips explained that in 33 cases no defence was made and \$165 was thrown away. It was considered right that every item should be explained.

On motiom of Coun Gallagher, the bill of Inspector Colpitts was read to the council again. The Inspector being on hand to make

explanations. Coun. Saunders moved seconded by Coun Bohan that the occount lie on the table till after the Inspector makes his report.

The Scott Act inspectors report as published above was then read.

The report was received. The consideration of the account was further deferred until the Inspector could get his books and explain

certain items. Coun. Brown on behalf of the committee on Dr. Curtis's bill regarding the Board of

Health, made a report showing that \$1004.05 had been paid in connection with the small pox experience last year. Since then bills amounting to \$583.53 had been contracted so that the small pox expense was \$1587. and some cents. As chairman of that committee he wished to say for the committee that some of these items would bear crit-

The annual report of the Board of Health was then read by Coun. Brown as follows: To the Warden and Councillors of the Mu-

nicipality of the County of Carleton: Gentlemen, -I beg leave to submit the annual report of the Board of Heaith for District No. 10, for the year ending Dec. 31,'02. Smallpox visited the district again this year appearing first in Grafton, the infection no doubt coming from Woodstock. There were 48 cases in Grafton and five in other parts of the county. Every effort was made to stop the spread of the disease and to do it as cheaply as possible. Dr. Sprague was employed to attend the patients and Mr. Geo. Hale, the agent of the board for Northampton, was engaged to look after the quarantine and supply the different families with the necessities of life. There was no further spread of the disease after the board took charge. Diphtheria appeared early in the year in the parish of Kent, and in the effort to stamp out the disease some money was spent. At the present time with the exception of some cases of measles there are no known cases of infectious diseases in the county. The statement of the money expended during the year accompanies this report as does also an estimate for the year 1903. Chairman Local Board of Health, District No. 10. Continuing Coun. Brown said that in some

cases not only necessaries but luxuries had been provided. He did not think that Dr. Curtis should have been given carte blanche to provide the amounts that the county should pay.

The sec-treas explained that the Board of Health was a body corporate which had power to contract bills, and if the county refused to pay them, the board could appeal to the government, and the warden could be called upon to show cause why the bills were not paid. Large powers were placed in the hands of the Board of Health, which the government no doubt deemed necessary.

Coun. Williams wished the reporters to place this matter before the public, showing the powers of the board.

The sec-treas said the county could always refuse to pay bills, but the warden would be called to show cause, and if he cannot the county must pay.

Coun. Merrithew asked if a good cause was shown what would happen?

The secretary said if good cause was shown, the county would pay the costs of the entire proceedings.

Coun Saunders thought that while there were some little things that might be criticised, the bills on the whole were fair, and that it was poor pelicy to take up too much time with them.

Coun Williams thought that Dr Curtis' charge of \$15 a day for attending patients in Hartland, was strange, considering his explanation last year that the government would agree to \$12 a day as reasonable.

Coun Bohan explained that Dr Curtis' charge of \$15 was in order to save expense, as Curtis thought two visits a week, which he would make, would cover the cases and save the charge of Dr Sprague of \$10 a day.

Coun Brown thought Dr Ross' bill which was not itemized, was a large bill to pay without explanation.

Coun Gallagher thought the bill should be

Coun Saunders explained that the board of health had power to vote these bills, but the

Coun Brown thought Coun Saunders was a peace at all price man and was too anxious to be pacific.

Coun Skinner thought it was time to stop paying bills we were not legally bound to

Coun Merrithew thought that the report should be received and a strong recommendation be made to the board of health in reference to these bills.


