THE ELECTION TRIAL.

Opening of Case for Petitioner.

The petition of J. Randolph Hartley Simms against the return of Wendell P. Jones on the 18th day of February last as a member of the Legislative Assembly of New Brunswick for the County of Carleton was heard before Justice Barker yesterday at the Court House.

Mr. A. B. Connell, K. C., appeared for the petitioner and Attorney General Pugsley | his leaving Woodstock and all wish him every and Mr. F. B. Carvell, M. P., for the respondent. Mr. Fred DeVine was present in the capacity of stenographer.

Before the petition was read to the Court the objection was made by the Attorney some corrupt practice on the part of Mr. Jones, the candidate, which it did not do. He also contended that the proceedings should take the form of an action against the sheriff and not a petition against the return of the candidate. The statute did not provide for the latter.

Mr. Connell replied that the election law provided for the bringing of a petition as had been done as well as the bringing of an to another part of the Province. action against the sheriff. He also asserted that any irregular proceeding or corrupt practice on the part of the returning officer was sufficient ground for the bringing of such an action.

His Honour, Justice Barker, decided that, whatever the proper construction of the statute might be, the Court would first hear the evidence and would take into consideration the points of law involved and decide thereupon at a later stage.

Mr. Simms was sworn and gave evidence as follows:-"On the 18th day of February last I came to the Court House. I arrived at the Court House at about 10 or 15 minutes after eleven. When I arrived there were present in the barrister's room Sheriff Hayward, Mr. Jones. Deputy Sheriff Foster, Mr. John S. Leighton, into the court room I found that Mr. Boyer, who had witnessed the signatures of the names of the parties who had signed my nomination paper, had not sworn to the same. I telephoned to Mr. Connell's office for Mr. Boyer. After telephoning I remained in the barristers' room until about twelve minutes of 12 o'clock. I came out and I looked for the bible. I could not find it. I asked for it. The Sheriff said "It is here somewhere." Mr. Boyer, Mr. Foster and myself searched for the bible but we could not find it. I said "This is pretty conduct in the supreme court room of the County of Carleton. This is not justice in this land of ours." I was angry and indignant. Mr. Boyer, Mr. Golding and I went down to the house of Mr. Wright. Mr. Golding swore Mr. Boyer to the nomination paper there. When I came back to the Court house it was four minutes to twelve. I said to myself "The situation is mine."

As Mr. Simms had not finished giving his evidence at the hour of going to press we are compelled to conclude our report of this important trial with this forceful utterance of Mr. Simms. Next week's issue of this paper will contain a full report of the entire proceedings. Both parties have maintained that they desire only the fullest investigation into the proceedings at the Court house on the 18th day of February. The machinery of the law has been set in motion to grant this investigation and we shall give a thorough and impartial report of the same.
