Three Acres Enough.
A most interesting chat was enjoyed between stations while on the Farming Special, with A. A. Eastman, who fully deserves the name of "the small fruit wizard" of Dexter. Mr. Eastman was formerly a shoemaker and gradually began dabbling in small fruit as a side line. So fascinating, and withal so profitable did the returns appear, that he was led to desert the awl and last and devote his entire time to small fruits.
His early operations engaged in taught Mr. Eastman that but small area rightly handled was sufficient to occupy his time and afford good financial returns, and the three acres of well adapted soil has been found amply sufficient for such use. His time is given largely to gooseberries, and the cane-producing berries, together with the production of strawberry plants, the raspberry plants grown for sale having been found more profitable to him than the berries. A few choice apple, plum and other fruit trees help make up his producing equipment, but it has been found that potatoes and other vegetables for family use can be purchased from the proceeds of a little patch of small fruit much more satisfactorily.
As an illustration of what his methods of production will do, we learned that his gooseberry crop sometimes reaches 200 bushels in a year, and that a plat 57x75 has produced 80 bushels of these berries.
An idea of the quality of his berries may be learned from the fact that a bushel of his Cuthbert raspberries shipped to the Boston market last season, brought 30 cents per quart, or \$9.60 for the bushel. These are but a sample of his operations. Mr. Eastman depends largely on Bar Harbor and Boston for markets for small fruits.

Archibald: "If it wasn't some of the specimens wading around in it would get drowned."

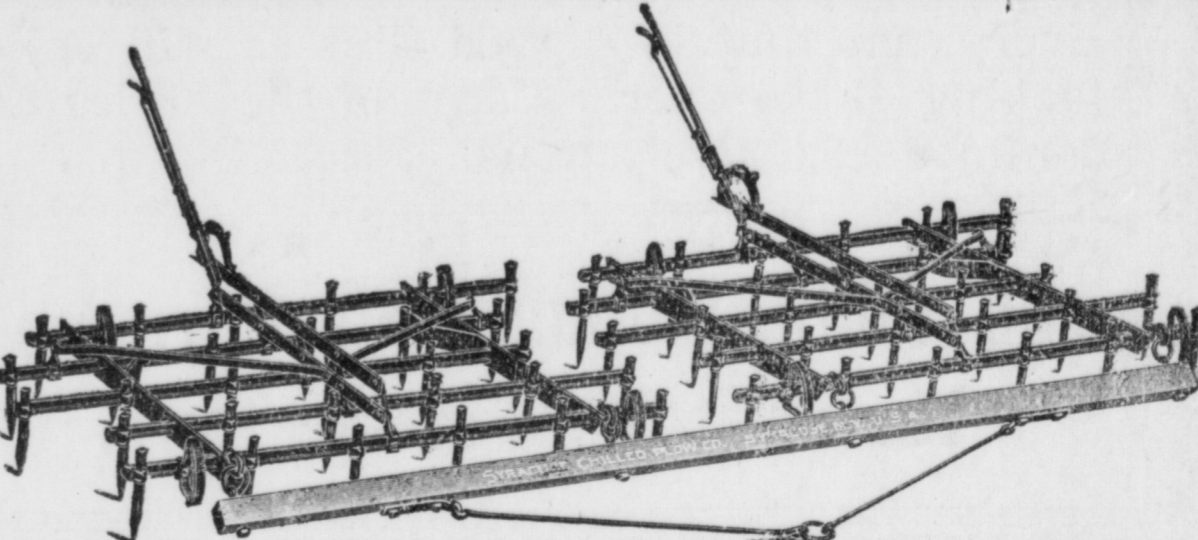
