Canadian Pacific Railway Plans.

FREDERICTON, Jan. 8.—J. W. Leonard,  
assistant general manager of the C. P. R.;  
W. R. McInnes, traffic manager; W. B. Bull-  
ing, assistant traffic manager; Wm. Downie,  
general superintendent of the Atlantic division;  
J. N. Sutherland, general freight agent;  
C. R. Ord, superintendent of mechanical  
department, arrived here today on a tour of  
New Brunswick. Merchants and shippers  
were called on and matters of mutual interest  
discussed. Mr. Leonard confirmed the state-  
ment that the C. P. R. was having a survey  
made from Debec, near Woodstock, to Ban-  
croft, Me., for the purpose of giving the C.  
P. R. and the Maine Central a shorter line  
from Aroostook county and northern New  
Brunswick to Boston for the purpose of  
better competition with the Bangor  
and Aroostook railway. The survey  
being made at present he said, was a prelimi-  
nary survey, and nothing very definite could  
be told from it.

Disuse of Hair Powder.

During the last year of the eighteenth  
century the price of grain in England was  
very high. So much flour was used as hair  
powder that an attempt was made to check  
its use. A recent book, "At the Sign of the  
Barber's Pole," contains a copy of a docu-  
ment issued by the "mayor, justices and  
principal inhabitants" of Great Yarmouth,  
recommending the disuse of hair powder for  
a time.

"We flatter ourselves," they said in this  
proclamation, which was issued in January,  
1795, "the military will not hesitate to adopt  
it, being fully convinced that appearances are  
at all times to be sacrificed to the public weal,  
and that in doing this they really do good.  
January 27 1795."

In the following April a party of gentlemen  
at Woburn Abbey entered into an engage-  
ment to forfeit a certain sum of money if any  
of them wore their hair tied or powdered  
within a certain period.

Nevertheless the Tories regarded with dis-  
trust persons who did not use hair powder.  
So late as 1820 a certain Major Cox of Derby,  
an excellent Tory, declined to allow his son  
to become a pupil of a well-known clerical  
tutor, for the reason that the clergyman did  
not powder, and that he wore his hair short,  
which suggested that he must be a dangerous  
revolutionist.


