The secretary-treasurer explained that there was a legal charge, it was only a question of the fee, that the council could con-

Coun. Connolly would like an understanding about the Shannons. If Mr. Woolverton had one warrant, Mr. Foster had only two and he charged mileage for three warrants.

Sheriff Foster said in these arrests he used his own judgment. He charged mileage on three warrants, Woolverton charged nothing on mileage. He charged a straight bill at \$5.00.

Coun. Connolly-He (Woolverton) said he had one warrant.

Mr. Foster said he (Woolverton) had one warrant when they got to the parties, as an assistant wished a paper to justify him if he personally made arrests.

Bill ordered paid.

Joseph Cheney, witness fees,..... 3.60 To be paid when attested. Press Publishing Company, ..... 2.00 Committee rose and reported.

On motion of Coun. Flemming Jas. F. Sanborn and Augustus Hand were appointed poundkeepe, etc. for parish of Woodstock.

On motion of Coun. Mellville Edward Foster was appointed pound keeper, etc., for parish of Peel.

On motion of Coun. Connolly H. B. Boyer's name was taken off the list of constables for the parish of Brighton by his own request. Coun. Connolly explained that Mr. Boyer wished to be relieved, hence his motion. On his motion, also, Frank L. Clark was apappointed a fire-warden for the parish of Brighton.

On motion of Coun Kinney, Willis Broad, Benjamin Hagerman and Michael Doherty and Frank Maskell. Lawrence Holbron and Thos O'Donnell were appointed poundkeepers for the parish of Kent and the name of John Kilfoil struck off the list of poundkeepers,

Under new business-Coun Kinney moved seconded by Coun. Keenan the tollowing resolution.

"That in the opinion of this council the time has arrived to take steps for the erection of a suitable Court House on the county lot in the town of Woodstock, and that the Building Committee be instructed to secure plans and specifications for such a building with a view of advertising for tenders for the construction of the same as soon as possible.

Coun. Wiley moved seconded by Coun. Williams, that no action be taken at the present time, but that the matter be laid over until the January session of the council

The amendment was carried.

Coun. Balmain-It is customary for the council to grant authority to the sec-treas and the finance committee to borrow \$5000 in case of necessity. There is already authority to borrow \$5000 but in case more is necessary it becomes necessary to empower the parties spoken of to make a further loan. According to custom I move that the finance committee and the sec-treas have authority to borrow \$5000 if necessary.

The sec-treas explained that at this time of the year there was always a deficit and would be until the taxes were collected.

Coun. Williams asked how the defaulters list stands.

Mr. Hartley-I think the collectors are doing very well.

Coun. Mellville-What interest do we have to pay on the overdraft?

Coun. Balmain-Six per cent.

Motion duly seconded and passed.

Coun. Jameson brought up the case of a man named Beckwith who about a year ago bought a farm from one Gregg. He had paid taxes which he thought should be refunded to him.

Mr. Hartley-That is a matter of arrangment between him and Mr. Gregg. It is not a matter to come before the council. The county has a lien on all lands for taxes for three years from the making up the assessment, and it holds good for school, county or rood takes. It holds from the date of the

On motion of Coun. Alex Bell seconded by Conn. Fewer, is was ordered that Walter Trecartin be paid \$20 on account and in set-

tlement for building fence on county lot. Coun. Carvell-I have just been talking with Mr. Kearney in this ferry matter and he says the other nian is cutting the fees.

I would like to ask if the fees are not set.

Mr. Hartley-Certain fees are set by law and a ferryman cannot charge more than those fees, but he can ferry for nothing and you cannot stop him. If he charges more than the set fee he is liable to a fine of not less than \$2 and not to exceed \$20.

Coun. Bailey produced certain plans of the counties which were owned by Mr. J. N. W Winslow and which he was willing to sell to the county for \$75. That of Wakefield was

Coun. Fewer moved, seconded by Coun. Balmain, that the plans of the parishes except Wakefield be purchased from J. N. W. Winslow and be placed in the Record office under custody of the Registrar, and the price paid be \$75.

Mr. Hartley-I have been asked to bring this matter up. These are plans showing all the grants. It is considered they would be valuable for the county for school purposes if placed in the record office. There is a plan of each of the parishes but Wakefield. Mr. Winslow will sell the plans as they are for \$75 or he will have Wakefield supplied and the plans revised for \$125.00. They have been made since the school law came in

Coun. Flemming-I think it would be quite a good thing to have these plans if they are to be kept in the Record office, I think it would be quite a convenience to the people of the county and would not cost very

Coun. Raymond-I do not understand they are complete up to date. It would be better to see what we can get up-to-date

Coun. Connolly-It looks to me as if it was like a person who wants to palm off some old furniture and out of fashion as if the man wants to get rid of them.

Coun. Williams-I do not see any benefit the county will derive from these plans, they must be 30 or 40 years old.

Mr. Hartley-No, they were printed since

Coun. Melville-I do not propose to buy old stuff.

Question put and lost.

On motion A. R. Foster was ordered paid \$2 for his attendance at Council this session. On motion Council adjourned sine die.

The Finance Committee reported recommending an assessment of \$8,500.00 and on motion same was received and ordered the same be assessed.

On motion bill of Dr. Curtis was ordered paid at \$7.00.

On motion ordered that \$150.00 be assessed on Upper Woodstock road district, \$100. to be expended on roads and \$40.00 on sidewalks and same be paid to Walter Trecartin. On motion one half debit balance of the several parishes was ordered assessed upon the respective parishes in the county.

Moved by Coun. Raymond seconded by Coun. Mooers, that commission to collectors be paid on amount collected in Parish of Simonds. Carried.

Moved by Conn. Carvell seconded by Coun. Williams, that \$70.00 be paid overseer W. H. Carvell and charged to Parish of Wilmot. Carried.

On motion the percentage to assessors and collectors was fixed at same as last year in all the parishes (as per correction to minutes reported at June session) "and commissions to be paid on amounts collected only."

On motion revisors were ordered paid same as last year.

Moved by Coun. Brown seconded by Coun. Fewer, that the delegates to Ottawa on G. T. Pacific matter be paid \$50.00 each.

Report of Finance Committee was submitted and on motion same was received. The Warden then appointed the following

standing committees:-Building Committee - Fewer, Flemming nd Alex. Bell.

Finance Committee - Balmain, Williams

Coun. Alex. Bell "Whereas the tendency for a number of years past on the part of the Provincial Legislature has been to lessen the powers of the municipal councils and vest the power thus taken from the councils in the Lieutenant-Governor and members of the Executive of the Province, And, Whereas the Highway Act of 1904 imposes a direct money tax on the people for the maintenance of the highways of the province, And Whereas the tax so imposed is assessed and collected and the account thereof kept by officers appointed by the councils, And, Whereas the control of the moneys thus collected under the Highway Act immediately passes into the hands of the government of the province and is expended by officers appointed by them, Therefore, be it resolved, that this council is of the opinion that in the interests of the public the control of the money so collected under the said act ought to be vested in the councils of the various municipalities. And this council is further of the opinion that the above Act does not make proper provision for the keeping open and in good condition the highways of the said province in winter. And further resolved that a petition setting forth the ideas and provisions of this resolution be prepared by the secretary-treasurer, signed by the proper o fficers, and forwarded to the government.

Moyed by Coun. Williams seconded by Coun. Lamont, that the sec-treas be instructed not to pay any further rent for the chambers of the County Court Judge after the first of February next. Carried.

Moved by Coun. Hay seconded by Coun. Alex Bell, that legislation by asked to make the poor of the county a county charge instead of a parish charge. Lost.

Moved by Coun Tompkins seconded by Coun. Brown, that bill of William Dibblee

for \$95 be paid. Moved in amendment by Coun. Williams seconded by Coun. Wiley, that bill be laid over till June session next. Amendment

On motion bill of W. P. Jones for \$300 was ordered paid.

On motion bill of Dr. N. P. Grant \$4 was ordered to be paid when sworn to.

Moved by Coun. Brown seconded by Coun. Carvell, that a memorial be prepared to-day-Patent and Gun Metal and forwarded to legislature asking that provisions be made for the payment of secretary treasurer for work done in connection with the road fund. Carried.

On motion A. R. Foster was ordered paid \$4 for attendance at Council.

On motion secretary treasurer and Finance Committee was authorized to borrow from Bank any sum not exceeding \$5000 in addition to amount authorized by Act of Assembly if needed.

Moved by Coun. Flemming seconded by Coun. A. G. Bell, that a committee of three from this council be appointed to interview the town council respecting the license laws of Town with a view of change of same.

The warden appointed as such committee Couns. Flemming, Forrest and Phillips.

Moved by Coun. Phillips seconded by Coun. Brown, Resolved, that this council petition the Provincial Government to enact a law that any candidate offering for County Councillor shall deposit the sum of at least \$25 with Parish Clerk before filling his nomination. In case he does not receive one half the number of votes polled by the lowest candidate elected this amount to be forfeited to the parish. Lost.

Moved by Coun. Forrest, seconded by Coun. Brown, that \$20 be contributed by the county to aid in the construction of a fence between Trecarten's and the county.

Moved in amendment by Coun. Connolly seconded by Coun Tompkins, that the matter be laid over till the June session. Carried. Council adjourned sine sie.
