#### Dr. Bailey to Retire.

A meeting of the Senate of the University of New Brunswick was held last Thursday morning in Fredericton.

Several communications were read, including one from Prof. Bailey, who intimated that he intended resigning from the faculty at the close of the present year, and he asked the senate to make him a retiring allowance sufficient, with his pension from the Carnegie fund, to equal his present salary of \$1,600. No action was taken. Dr. Bailey, who has been on the university staff forty-six years, is to receive from the Carnegie fund a pension equal to two-thirds of his salary.

A dispatch to the London Times from Wellington, New Zealand, says: "It is thought some people in New Zealand, whose opinions are entitled to weight, believe that our anti-Asiatic legislation is destined eventually to bring us into serious conflict with eastern nations. Popular opinion, undoubtedly, strongly favors exclusive measures. A statement by Premier Ward last night that New Zealand will not allow the entrance of any impurity from eastern lands or races into the colony permanently was loudly cheered. That, he added, was one reason why Great Britain should maintain a navy double the strength of any other power, and why New Zealand must contribute to make that navy capable of what might be requiree of it.
