### The Cost of Three Martyrdoms.

A bill for the materials with which to burn Cranmer and his fellow-martyrs is still in existence. The execution of Latimer and Ridley took place on October 16, 1555, while Cranmer did not suffer until March 21 of the following year.

The memorandum of the bill is included in the book which was found by Strype when he wrote his "Memoirs of Archbishop Cranmer" in 1693, in which the expenses of the martyrs were endured during their imprisonment. This book is somewhere among the manuscripts of Oxford University now, a grim, matter-of-fact witness to the fanatical hatred of the day.

The following are extract transcripts from the bills by the persons who had charge of the funeral piles:

"Paid for the burning of Archbishop Cranmer and his two fellow sufferers, Ridley and Latimer: For one hundred of wood fagots, 6s; for one hundred and a half of furze fagots, 3s 4d; to the carriage of them, 8d; to two laborers, 1s 4d; to three loads of wood fagots to burn Ridley and Latimer, 12s; item, one load of furze fagots, 3s 4d; for carriage of these four loads, 2s; item, a post, 1s 4d; item, for chains, 3s 4d; item, for staples, 6d; item, for laborers, 4d."

### How the Apostles Met Death.

Though the manner in which the Apostles met death has been the subject of considerable controversy, church traditions give the following accounts of their fate:

St. Matthew is supposed to have suffered martyrdom, or was slain with a sword at the city of Ethiopia, in Egypt.

St. Luke was hanged upon an olive tree in Greece.

St. John was put into a cauldron of boiling oil at Rome and escaped death. He afterward died a natural death at Ephesus, in Asia.

St. James the Greater was beheaded at Jerusalem.

St. James the Less was thrown from the pinnacle or wing of the temple, and then beaten to death with a fuller's club.

St. Philip was hanged up against a pillar at Hieropolis, a city in Phrygia.

St. Bartholomew was flayed alive by the command of a barbarous king.

St. Andrew was bound to a cross, whence he preached unto the people until he expired. St. Thomas was run through the body with a lance at Coromandel, in the East Indies.

St. Jude was shot to death with arrows.

St. Simon Zealot was crucified in Persia.

St. Matthias was first stoned and then

beheaded.

St. Barnabas was stoned to death by the Jews at Salania.

St. Paul was beheaded at Rome by the tyrant Nero.

Catholic authorities state that the bodies of the Apostles are now in the following named places: Ten are in Italy—namely, Peter, Philip, James the Less, Jude, Bartholomew, Matthias and Simon being in Rome, and Matthias at Salerno, Andrew at Amalfi, and Thomas at Orta.

One in Spain—James the Greater, whose remains are in St. Jago de Compostella.

Of the body of St. John the Evangelist, the remaining one of the twelve, there is no knowledge.

The evangelists Mark and Luke are also in Italy—the former at Venice and the latter at Padua.

St. Paul's body is also believed to be in Italy. Peter's is, of course, in the church at Rome which is called after him, as are also those of Simon and Jude. Those of James the Less and of Philip are in the church of the Holy Apostles; Bartholomew's in the church on the island in the Tiber called after him; Matthias's is in the Santa Maria Maggiore under the great altar of the renowned Basilica.

### The Roulette Wheel.

Strange as it may seem, the roulette wheel, that alluring machine by which so many fortunes have been won and lost (mostly lost), was devised by a monk, Pascal, during a six months' "retreat" for meditation and prayer. He probably little realized the gigantic popularity as a gambling device his simple invention would in later years attain. In Monte Carlo, the greatest gambling resort in the world, more than \$5,000,000 are lost by players every year. The Casino at Monte Carlo is controlled by a firm which styles itself "the Sea Bathing and Strangers' Club company." Though no one was ever known to dip a toe in the surf at Monte Carlo during the winter season, the profits of this company in the winter season of 1904-05 amounted to \$7,204,000.—Booklover's Magazine.

### Paper Handkerchiefs.

"The paper handkerchief, unlike the paper collar, is here to stay," said a physician. "It has a good reason for remaining, and that is what the paper collar never had. The paper handkerchief comes to us from Japan, where for centuries it has been in use. It is soft and thick and strong, and it looks like silk. It costs a cent—less than the cost of laundering a linen handkerchief. The linen handkerchief, physicians agree, is the most dangerous article in the human wardrobe. It swarms with billions of germs of consumption and grip and pneumonia, and hence, instead of being laundered, it should be destroyed. But it can't be destroyed; it is too expensive. The paper handkerchief is destroyed. It is thrown into the fire. The rarity of consumption in Japan is attributed, with some show of justice, to the exclusive use of paper handkerchiefs by the Japanese."—New York Press.

### Couldn't Divide Time Between Two Hobbies.

Mrs. Mary Ann Williams McClement-Tibbets tried the novel idea of having a husband in the United States and another in England, but it did not work well, and all she has now is a divorce in England and a peculiar position in America.

Mary Ann Williams was a widow when William McClement, a Scotchman, married her in Manchester. She had a son, who emigrated to America and settled in Kansas. A year or so after her second marriage she decided to go to Kansas and visit her son. There she met E. J. Tibbets, a well-to-do Kansan, and became acquainted with him posing as the widow of Williams. He proposed and she accepted. They were married and had a honeymoon which lasted some months.

Then Mrs. Tibbets, as she was, of course, known, said she would have to visit England on business, but would be back in six months or less. In England she returned to her home and husband, McClement. Thus her plan was worked out. Six months she would spend with him in England, and the same period with her other husband in Kansas. But the English husband found some letters and other things, and began an investigation. The result was the granting of a divorce here last week.

Mrs. "What-her-legal-name-may-be" is not being prosecuted for bigamy, for she is with Mr. Tibbets in Kansas, but the English court has now given him a chance to really marry her.

### Mounted Police In The Far North.

The plans of the Mounted Police for the present season include the opening of a route of winter communication from the head of Lake Winnipeg to Fort Churchill, on Hudson Bay, a distance of a little less than five hundred miles. When the police are more firmly established on the Bay and get a post planted at what is known as Bakey Lake, it is intended to open a trail across the barren lands that separate Chesterfield Inlet from Great Slave Lake. This is a route that very few white men have as yet traversed. The opening of a trail, however and the building of a few huts thereon will no doubt be followed by exploration to ascertain what it contains. There is mineral wealth still further north and it is hard to say what metals these remote regions may not possess. The supply steamer 'Adventure' on which Major Moody sails for Hudson Bay the last week of this month carries 1,100 tons of coal for the police posts. The police are hopeful, however, that deposits will yet be found in the Hudson Bay region. Large coal areas have been uncovered further north.

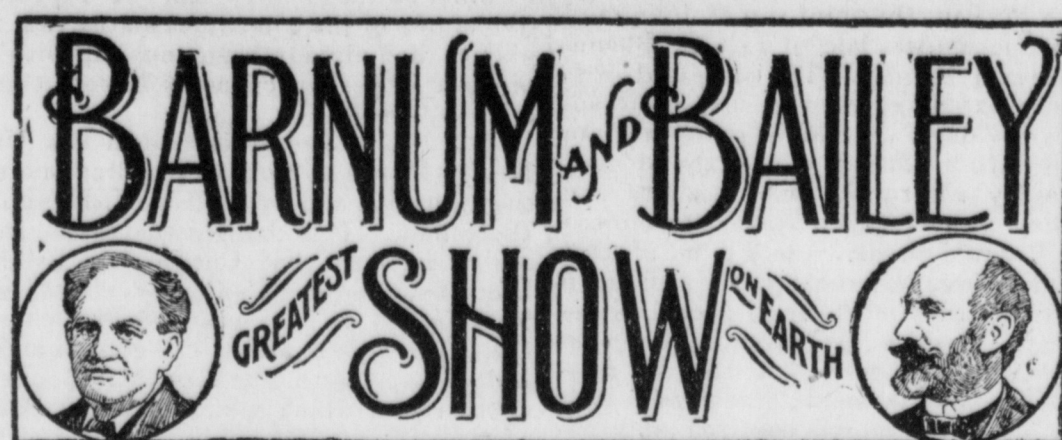

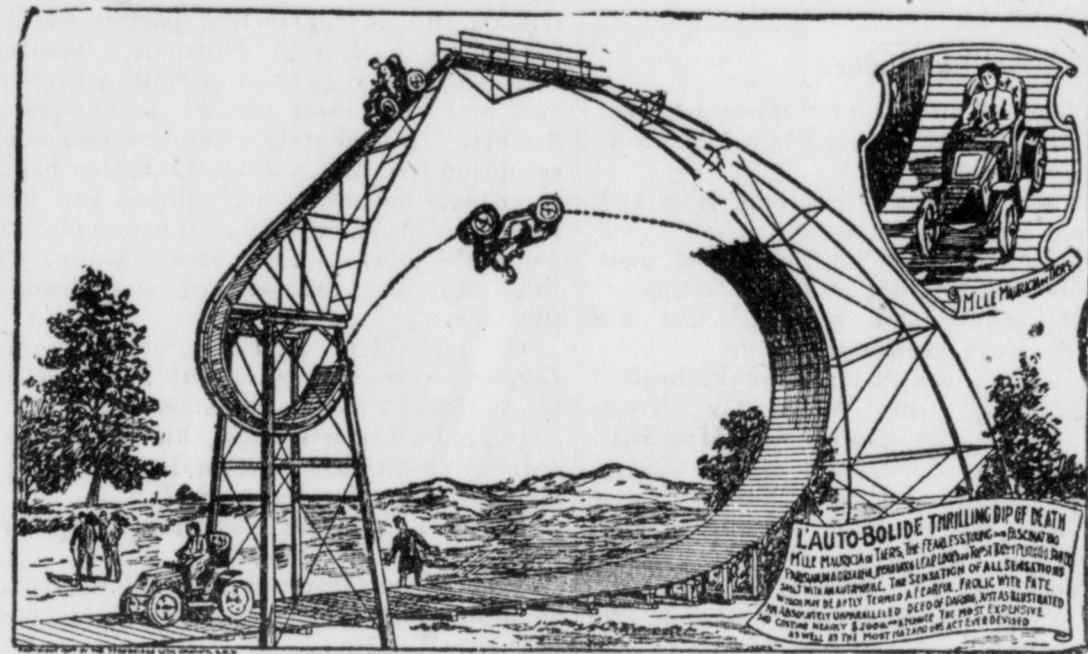

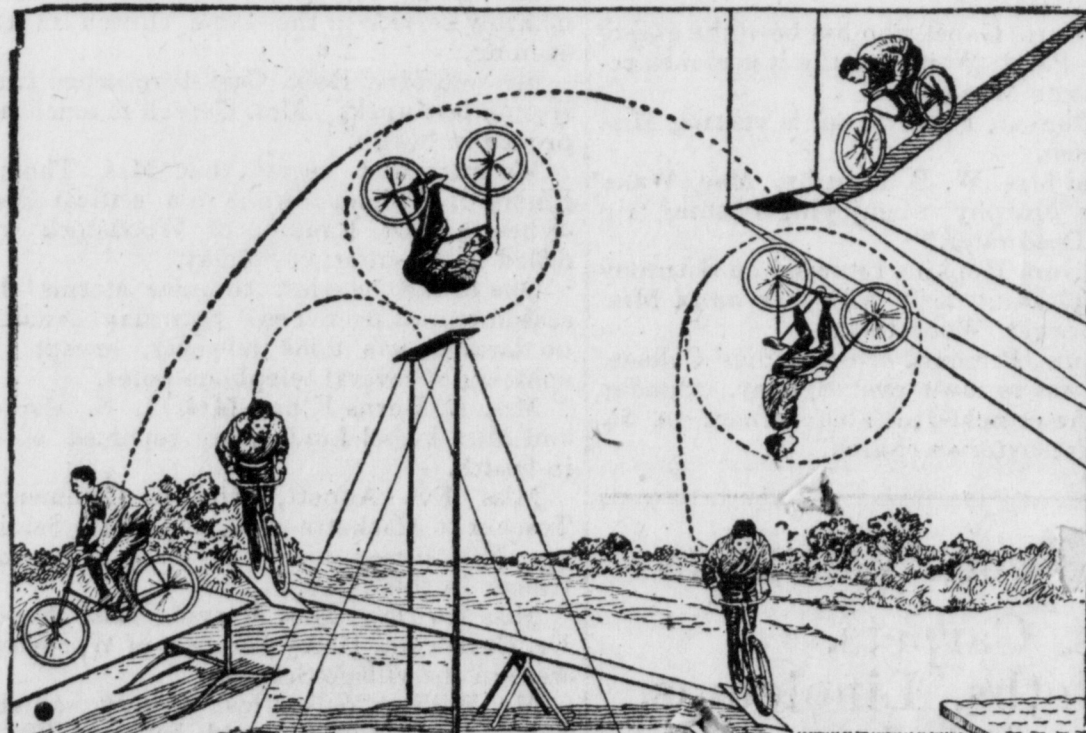
