The Reactionary Russian.

Pan-Slavism is a movement which aims not only at the union of all Stavic people under the Russian crown, but also the domination of Russian power in Europe, and Asia. It is both political and religious, holds the Greek Church to be the only faith and destined to supersede all other forms of Christianity. Politically, 15 regards modern ideas of liberty, constitutional representative government, and religious freedom as fundamental errors. This attitude its exponents logically maintain by the argument that as there is one God on high, there must be one ruler on earth, and only one true religion. The most prominent representative of Pan-Slavism, now that Pobedonosteff has departed this life, is General Spiridovitch, who is reported to be about to start for the United States in the interests of a movement in Russia to form a Russo-American alliance against Japan. It would be impossible to imagine two political systems more diametrically opposed to each other than those of Russia and the United States. They have absolutely nothing in common. Only an enthusiast, looking on the world through Pan-Slavic spectacles, could conceive an alliance of them against Japan as at all with-

The Proposition to Guarantee Bonds

Last week a bill passed the legislature to allow the town council to submit to a vote of the property holding ratepayers the question as to whether or not they approve the guaranteeing by the town of the bonds of the Alexander Dunbar & Sons Co., Ltd., for an amount not exceeding \$50,000 at a rate of interest not exceeding 41 per cent., for the purpose of enabling the company to enlarge its plant within the town.

Thirty days notice of the time and place of taking such vote must be given.

Before the town may guarantee any such bonds the company shall have en larged their plant and the guarantee shall be for not more than 50 per cent. of the money invested in their plant.

The company is required to keep its plant insured to the satisfaction of the town council.

The interest on the bonds shall be paid by the company semi-annually.

The principal sum guaranteed shall be repaid as follows: One thousand dollars per year for the first five years from date thereof; two thousand dollars per year for the next five years; three thousand dollars per year for the next five years and four thousand dollars per year for the remaining five years.

During the time the guarantee is in force the town council is to have the power of electing one director to the board of directors of the company, such board not to exceed five.
