Dr. Stockton, M. P. Dead.

Dr. A. A. Stockton, Conservative member for St. John, N. B., city and county, died last Friday morning in Ottawa, making the eighth vacancy that death has made in the ranks of parliament during the present session. Dr. Stockton suffered a chill some weeks ago, which brought on a renewed attack of a serious ailment for which he had been operated on a few years ago. For a time it looked as though he were improving, but this was followed by an attact of pleurisy, to which he succumbed. The deceased was sixty-four years of age and a native of Kings county, New Brunswick. For the sixteen years from 1883 until 1899 he represented St. John continuously in the legislature of New Brunswick, and for some time was leader of the Opposition in that body.

He was returned to the House of Commons at the last general election, and although not a frequent participant in the debates of that body has shown himself one of the most effective critics that the Opposition ranks contained.
