A bulletin about butter has just been issued by the laboratory of the Inland Revenue Department, Ottawa. One hundred and one samples of butter were examined. Of these 90 were found to be genuine, 4 doubtful and 7 adulterated. The chief analyst classes a sample containing over 16% water and one with less than 80% butter fat as doubtful. He says "the adulterated samples comprise 5 which contain excessive quantities of water and two which consist very largely of foreign fat. From the latter fact it would appear that oleomargerine in small quantities is either being imported into Canada or i being manufactured here."

Of the 5 samples found to be adulterated with water, one had 29.75% and another 30.15% of water, and the latter sample retailed at 23cts a pound. In a country as well watered as Canada, 23cts a pound is a pretty good price for the liquid. Ten per centwould seem to be an average amount of water obtaining from the Town Councillof the said Town in the samples examined, and one ran as low as 3.63 per cent.

One lot contained 12.11% of salt. This amounts to about two ounces to the pound. No doubt the Department of Inland Revenue would send a copy of this bulletin, No. 131, to any one who would apply for it.

#### TOWN COUNCIL.

Beer Law Passed--Wholesale License \$200.00 and Retall License \$100.00-Wm.1F. Bolger Appointed Chief of the Fire Department.

The regular monthly meeting of the town council was held in the council cnamber Monday evening. His Worship Mayor Munro and all the councillors were present.

After the report of the town treasurer had been disposed of, Coun. Noble, as chairman of the license committee, read the following bye-law:

#### A LAW.

To Regulate the sale of Non-Intoxicating Beer a a beverage within the Town of Wogdstock BE IT ENACTED AS FOLLOWS:-

1. That no person or persons shall exhibit or offer for sale or sell any Non-Intoxicating Beer within the said Town of Woodstock, without first of Woodstock a License therefor, under a penalty of not exceeding FIFTY DOLLARS for each and every offence.

2. All applications for such License shall be in writing, addressed to the Mayor and Town Council, and signed by the applicant, and shall particullarly describe the premises for which such License is to be used for the sale of such Non-Intoxicating Beer; and such applicant shall agree and declare that no intoxicating liquor will be kept on such premises so Licensed.

3. The Town Council shall decide to whom License may be issued to sell such Non-Intoxicating Beer under this ByeLaw; and no such License shall be issued to any person or persons who may have been convicted of violating the provisions of the Canada Temperance Act within one year preceeding the date of such application for such License, nor shall any Licensee employ as a Clerk or Manager under such License any person so convicted; and any person or persons to whom such a License shall be granted, who may afterwards be convicted of a violation of any of the provisions of the Canada Temperance Act, shall upon such conviction being made, suffer the immediate cancellation and forfeiture of any such License granted to him or them for the sale of Non-Intoxicating Beer under this Law.

4. All Licenses to sell Non-Intoxicating Beer under this Bye Law shall be for a term of one year from date of issue, and shall be signed by the Mayor and Countersigned by the Town Clerk under the Town Seal, and shall be issued only upon the understanding that the Town Council shall have the right to make and ordain any further Laws and regulations respecting the sale of such Non-Intoxicating Beer, in addition to any laws and regulations in force when such License was issued, as the Town Council may from time to time determine and such license shall be subject to such new laws and regulations.

5. The person or persons to whom such License shall issue to sell such Non-Intoxicating Beer, shall provide a Counter in such Licensed premises, arranged to the satisfaction of the license committee of the said Town Council or the Inspector or other officer appointed by the Town Council under this Bye Law, for the sale of such Non-Intoxicating Beer, and which Counter shall be in full view of and on the level with the street in front of such premises, and without any screen to prevent a full view of such Counter and during the hours provided for the sale of such Non-Intoxicating Beer the blinds on such premises shall not be down or drawn, and that all such Licensed places for the sale of such Non-intoxicating Beer shall close not later than twelve o'clock in the afternoon, and not to be opened until six o'clock in the morning, and shall not be allowed to be

6. The Town Council shall appoint an Inspector or other Officer to see that all the provisions of this law are complied with, and such Inspector or other officer shall have authority to visit, enter and inspect all premises where such Beer is licensed to be sold, as well as any other place or places where such Inspector or other Officer may have reason to believe that such Beer is being sold, and shall have power to examine and inspect all kinds of such Beer found on any such premi ses, as well as all other kinds of liquid beverages on such premises, and if such Inspector or other Officer finds on such licensed premises any intoxicating liquor, then in such case he shall immediately suspend such License, and make a report of such suspension to the Town Council, with the cause thereof, and the Town Council shall hear and determine whether such license shall be continued or cancelled and forfeited, and the decision of the Town Council in the matter shall be final and conclusive.

7. All informations and proceedings against any person or persons for any violation of this Bye-Law shall be laid and proceeded with in the name of such Inspector or other officer duly appointed by the Town Council, and all monies reand by him paid over forthwith to the Town

8. The Fees to be paid for such License to sell Non-Intoxicating Beer under this Bye-Law shall

Retail License Fee, for selling by the glass or single bottle only, \$100.00.

Wholesole License Fee, for selling other than above, \$200.00.

9. Any Licensee under the provisions of this elaborate.

Bye-Law who violates any of the provisions of the present bye-law, or any additions to the present bye-law, shall be liable to a penalty not exceeding Fifty Dollars in addition to the forfeiture of his License, for each breach of any section of this bye-law.

Coun. Noble seconded by Coun. Burtt, moved that the above be accepted and enacted as a bye-law of the town of Woodstock.

Coun. Noble seconded by Coun. Sutton, moved that the provisions of the bye law come in force the first of Jnne. Carried.

Coun. Fisher moved that John Tattersall's resignation as chief of the fire department be accepted. Carried.

Coun. Burtt, seconded by Coun. Hagerman, moved that Wm. F. Bolger be appointed chief of the Woodstock Fire Department, with the same salary as that received by Chief Tattersall. Carried.

Coun. Sutton, seconded by Coun. Fisher, moved that the street committee be authorized to grade a sidewalk on Richmond street from Regent street to Guelph street. Car-

His Worship said he had written to Engineer Murdock of St. John to get information about making a survey of the town. He had received the information asked for, and as it was a very important matter, he thought the council should take some steps in the matter.

The question was referred to the street committee to look over the information on hand and submit a report to the council.

Coun. Dunbar said that Grover street was in a very bad condition and dangerous to pedestrians and teams, and he moved, seconded by Coun. Sutton, that the street be put in a passable condition. Carried.

A letter was received from Robert Caldwell in regard to the Vendome building on Queen street, which had been damaged by a hydrant Referred to the water committee.

Rev. Mr. LePage complained of a nuisance near his place of residence and asked the council to remedy the same. This was referred to the health committee.

Mrs. Tacey complained that the town had caused damage to her property by excavating too near her lot. Referred to the street

The conneil decided to accept the offer of Mr. Tilley for the purchase of the boiler used for thawing out the hydrants for the sum of

A letter was received from E. S. Kirkpatrick, secretary of the 67th Regt. Band, stating that the band intended to put on a better series of concerts this season than ever before and would start them on Thursday evening of next week. He asked for a grant of \$10 for each concert. The matter was referred to the finance committee.

The following pound keepers were appointed : Wm. Lee, Charles Greer, G. A. White. W. B. Belyea, H. N. Payson and J. N. W.

Robert Welch, whose pool and billiard liceuse had expired, was given an extention of time until August 20th.

Coun. Hagerman asked that the water service be extended to the residence of Miss Smith on the Houlton Road. The water committee was authorized to get the cost of same and report to the council.

The water committee was authorized to put in a catch basin in St. Gertrude's street. A discussion here arose as to the electric light service the town was getting under the new contract. Complaints had been coming in trom different quarters.

Coun. Hagerman moved that a committee be driven around the town some evening to make an examination and see if there could not be some changes made in the location of the lamps so that the town would get a better service. Carried.
