#### Death of Maud Dow.

The death of Maud Dow, early Monday morning, July the first, has filled the community of Northampton with sadness and mourning. Miss Dow was a promising young woman, little more than twenty years of age, very popular among the young people and beloved by everybody. She possessed a cheerful, sunny and happy disposition, and was kind and thoughtful about others. At the funeral several of the older people were heard to remark upon the unselfish character of her life, and of the loss which the community had sustained in her death. The large attendance at the funeral, and the beautiful floral remembrances as well as the deep feeling that pervaded showed the esteem in which she was held.

Miss Dow died of typhoid fever, which she contracted while nursing her brother through an attack of this disease. The brother is recovering and was present at the funeral, but Maud, overworked and fatigued, was not able to resist the advance of the disease. Her mother, Mrs. Porter, and her sister and brother, the immediate relatives were present at the funeral. The funeral services were held at the home of her aunt and foster mother, Mrs. Orr, with whom she had made her home for many years, and to whom her death is the loss of a beloved daughter. Maud was an earnest christian and died with a firm faith in Christ. The funeral services were conducted by the Rev. W. C. Keirstead of Woodstock.—Com.

#### Death of A. Mariana Sharkey.

On July the 4th, after a lingering illness of three months terminating in empyema, Agnes Mariana, aged 16 years and 9 months passed away. The deceased was the eldest daughter of Mr. and Mrs. Geo. H. Sharkey, of Wakefield Centre, and leaves to mourn besides a father and mother, three brothers and three sisters.

The funeral took place on Saturday morning from her late residence to St. Gertrude's church where a Requiem Mass was celebrated by Rev. Father McMurray. The interment was made in the Catholic cemetery at Woodstock. The pall bearers were Messrs Willard and Eugene Sharkey, Daniel Callahan and Frank McGrath.

#### Mrs Margaret Tabor

Mrs. Margaret Tabor died at the home of her parents, Mr. and Mrs. Robert Hull, on Sunday July 6th, in the 36th year of her age, after a short illness of Bright's disease. The funeral took place on Sunday, interment being made in the Methodist cemetery. The Rev. W. C. Keirstead officiated. Besides her parents, deceased is survived by one sister, Miss Carrie, and seven brothers, James, Frank, Samuel, Robert, Lester, Clyde and Wendell.

#### Death of Mrs Wm Dickinson

The death occurred in Concord, N. H., on Monday, July 8th, of Nellie, aged 29 years, youngest daughter of Mr. and Mrs. John Blackie, and wife of William Dickinson. Deceased had only been married since last December. The remains are expected here on the express today, when the funeral will take place from the Queen Hotel. Besides her husband and parents she leaves one sister, Elizabeth Knowlton, and three brothers, Anthony, of Dawson city, Oliver, of Eureka, Cal., and Wallace, at home.

Rev. George D. Ireland will conduct the funeral service. The interment will be in Oak Mountain cemetery Richmond.

#### Jury Disagreed in Collins Case.

In the case of the King against Collins for the murder of Mary Ann McAuley the jury disagreed, standing 7 for acquittal and 5 for conviction. The case was tried before His Hon. the Chief Justice, His Hon. the Solicitor General W. P. Jones appearing for the crown and the Hon. H. A. McKeown for the prisoner.

It is freely stated that the question of the innocence or guilt of the prisoner was not a question of much argument, but the question of capital punishment seems to have been paramount. There will undoubtedly be a new trial and sweeping charges will probably be made in certain conditions of the administration of justice in the county.

#### A Conservative Daily for St. John.

W. H. Thorne, W. S. Fisher, J. R. Armstrong, Miles E. Agar, St. John; Josiah Wood, Sackville; John McKane, Newcastle; Richard O'Leary, Richibucto; Peter S. Archibald, Moncton, seek incorporation as the New Brunswick Publishing Company, capital \$80,000 divided into 16,000 shares of five dollars each, of which 8,000 shares are actually subscribed. The object of the company is to publish in St. John a daily morning newspaper, to be called the Morning Standard, devoted to the interests of the Conservative party. It is rumored that S. D. Scott will return from Ottawa to assume the editorship of the new paper.

#### New Church at Wakefield.

The new Episcopal church at Wakefield was consecrated on Sunday last by His Lordship Bishop Richardson in the presence of a large congregation. The consecration service began at 10 30 a. m. in which the bishop was assisted by the rector, the Rev. A. W. Teed and the Rev. C. Maimann. The service was very impressive and as the majority of the congregation had never attended a consecration service, it was followed and taken part in with much earnestness. The bishop's sermon pointed out that the object of church building was to inculcate reverence and bear visible witness to a higher life. In the afternoon at 3 o'clock a confirmation service was held, and again the capacity of the church was overtaxed. Four were confirmed. The bishop's addresses on confirmation were plain, forcible and practical. In the evening at 8 o'clock, evensong was said at which the Rev. Mr. Maimann officiated. This was a red letter day as it was a joyful ending of years of labor in the construction of the building, and the beginning of religious exercises and spiritual work in God's own house in this community.

#### A Shooting Affair.

Two Arabians, Mr. and Mrs. Lovitt, whose home is in Woodstock, went down to McAdam on the early morning train Monday. On the way down there was considerable scrapping between them. When they reached McAdam Junction they adjourned to the ladies waiting room and the affair culminated in Mr. Lovitt's drawing a revolver and shooting his wife in the stomach. Lovitt was promptly arrested and taken to Fredericton. Dr. Butler, of McAdam, was sent for and accompanied Mrs. Lovitt to Woodstock where she was taken to the hospital.

#### Some Business by the Town Council

At the town council on Friday evening the treasurer's report showed an overdraft at the bank of \$7492.77.

Mr. Dibblee, police magistrate, reported for the six months from January 1st to July 1st, fines paid \$28.00, fines unpaid \$55.00; costs \$7.50; balance due town \$20.50.

Pickel & Davidson were given the contract for constructing a sewer on Elm street at \$250 and \$1.00 a foot for ledge.

His Worship said the steam fire engine had arrived from Manchester, N. H. where it had been for the last five months undergoing repairs. He had no invoice for the repairs but the freight was \$148. On his suggestion it was ordered that the engine be re-tired and painted.

The new pump has arrived and is in position and the machinery is here. It has been ordered that debentures to the amount of \$6,000 be issued to pay for permanent improvements on the water system.

#### Houlton Child Burned to Death.

Florence K. Felch, aged 9 years, daughter of L. M. Felch, principal of Ricker Classical Institute, Houlton, was burned to death on July 4th. She was playing with fire crackers and her dress took fire.

#### Confirmation Service

After the consecration of the church at Wakefield. His Lordship Co-adjutor Bishop Richardson arrived in town on Sunday afternoon and preached in St. Luke's church at the evening service.

On Monday afternoon a reception was held in the Parish Hall from 4 to 6 o'clock, at which there was a large attendance. The following address of welcome was read to the Bishop by F. Byron Bull, Senior Church Warden, to which the Bishop made a suitable reply:

To The Right Reverend John Andrew Richardson, D. D., Bishop Co-Adjutor.

MY LORD,—On behalf of the Parishioners of the Parish of Woodstock and of the Mission in connection therewith, we beg to extend to you a hearty welcome on this, your first official visit to us since your elevation to the Episcopate.

We are not forgetful that in the time of our great sorrow, a few months ago, Your Lordship came to this town to assist at the last sad rites in connection with the death of our late beloved Rector, and we can assure that your coming to us on that occasion was deeply appreciated, and that the words you spoke to us found a deep place in our hearts and will not be soon forgotten.

On all sides we hear of the energy, ability and devotion you are bringing to bear on the affairs of the Diocese, and we can assure you from no parish or mission will you receive more hearty support in the arduous labours of your high office than from this which you are now visiting.

We can only express the hope that in your zeal for the progress of the work of the church you will not fail to remember that you owe it to us all that you take good care of your own health and that you do not allow yourself to be overworked.

We look for great things in the Church's work and influence during your Lordship's Episcopate which we trust may be extended for many, many years.
