

Reformed Baptist Alliance.

The Reformed Baptist Alliance opened last Thursday morning at Beulah Camp Ground.

Rev. P. J. Trafton, chairman of committee on Temperance, reported. Your committee on temperance beg leave to report:

1st. That we regret that more progress has not been made in the matter of national prohibition. We would urge upon our ministers and people the necessity of securing provincial prohibition; let us hope for good and honest men that will be pledged to support such a measure in the legislature regardless of party.

2nd. That the crushing out of this evil will help to answer the prayer of Christ, "Thy kingdom come," etc.

3d. We wish to praise God for the influence that the preaching of holiness has had on the church against the use of tobacco, morphine, etc., and we urge on our ministry and people the necessity of keeping the standard high.

On motion the alliance was instructed to secure the services of Rev. W. B. Yates of the south to lead the song service during the camp meeting, and this fact will lend additional interest to the services, as he and Dr. Carradine make most excellent co-workers. The alliance have also secured the telephone line between Rockdale Hotel and Brown's Flats, which passes through the camp grounds.

The alliance also selected J. H. Seely, Jos. Smith, F. H. Noble, D. L. Cosman, J. H. Coy to have charge of the Riverside, Maine, tabernacle and grounds during the coming camp meeting there in August. Rev. W. B. Wiggins B. A. was also continued as treasurer; Rev. S. A. Baker, H. C. Archer, P. J. Trafton, committee in charge of hotel at Riverside, Me.

The alliance decided that no admission fee will be charged for Sunday services at Beulah camp grounds, but a silver collection will be taken at the main entrance instead.

Afternoon session—Much important business was done.

H. G. Noble of Woodstock, treasurer of the sinking fund, reported that he had secured \$120.59.

The alliance has purchased the beautiful cottage of Mrs. K. K. Jones of Seattle, Washington, as they needed the additional room to accommodate the people coming.

The alliance, after much prayer, selected Rev. M. S. Trafton of St. John, Rev. S. A. Baker of Woodstock, Rev. W. B. Wiggins, Moncton, as preachers in charge of the coming camp meeting at Riverside, Me., in August, provided that they do not secure an evangelist for the meetings.

Rev. G. B. Trafton of Marysville was chosen as presiding officer at the Riverside, Me., camp meeting.

The grounds committee was instructed to clear up the lot opposite the grounds, outside the gate.

The treasurer, Elisha Cosman, of St. John, reported for the year expenses of the alliance in connection with his account, \$743.58; receipts, \$716.75.

The alliance ordered that 500 copies of the minutes be printed, including the articles of faith.

H. G. Noble, of Woodstock, reported that \$300 was raised this year to be added to the sinking fund.

By resolution of the alliance, Yarmouth and Digby and the Annapolis Valley were constituted a district, No. 4.

Miss Maude Colwell, of St. John, presented an excellent Sabbath school report, showing twenty-two schools reported, 1,291 scholars, and twenty-one conversions among the young people.

A very interesting letter from Dr. Saunders of South Africa, dealing with missionary work on the dark continent, was read and the Rev. S. A. Baker was instructed to prepare a suitable reply.

At the afternoon session the manager of the denominational paper, the Rev. Mr. Baker, reported a good financial standing and all expenses paid without advertisements.

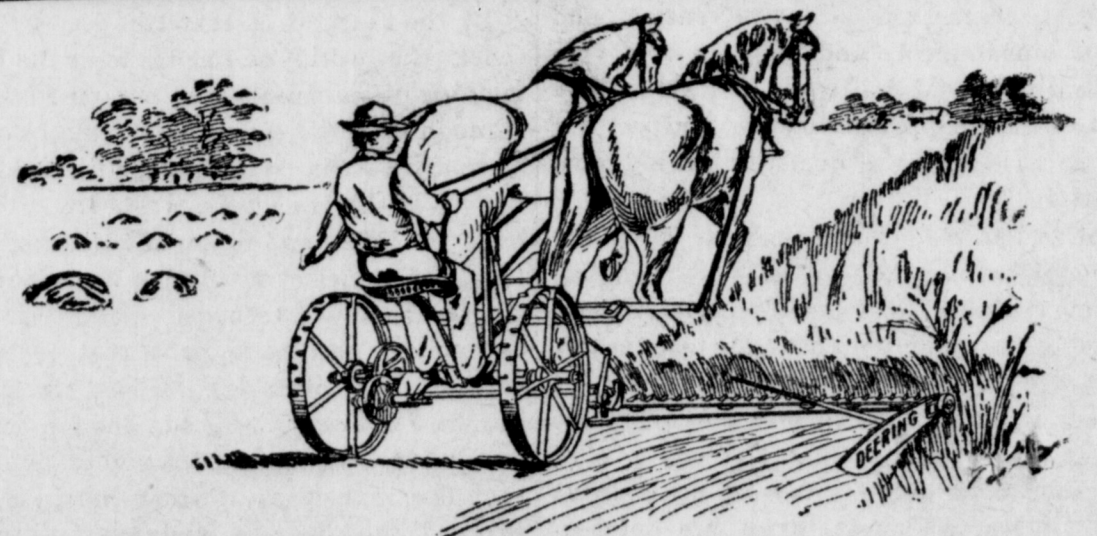
