

#### New Public Highway.

Petitions are being circulated in the Town of Woodstock and in the Parishes of Northampton and Southampton asking the Local out what is known as "Wright's Creek" or the "People's Road" in a aouth-easterly direction through Kilmarnock and extending on to Campbell Settlement.

having this road opened up. Considerable public money has been expended on the upper end of it on what is commonly called the "People's Road.

This road, if opened up, would bring Camp-bell Settlement and the upper portions of the parish of Southampton within sn easy one turn road of Woodstock, whereas now the distance is about twenty-four miles.

Considerable railway and other wild lands are along the route of the proposed road and make a large difference in the trade and gen-

eral prosperity of the town. The length of the proposed road is about fourteen miles, some of which is already roughly prepared for wheeled vehicles. When it is considered that in this direction from Woodstock there are upwards oi twenty thousand acres of rallwsy lands as well as other granted wild land within a radius of fifteen miles of the Town of Woodstock, it seems about time that something

had been done that the Town of Woodstock should have the proper chance to increase of this land.

It was moved by Coun. J. Rankin Brown, seconded by Coun. John Williams, that the plans of Mr. Brodie of St. John be accepted Carried.




