

HARTLAND NEWS.

Forest fires have been doing much damage in this section of the county lately. Last week the large barn situated on the rear of Darius H. Nixon's farm caught fire and was destroyed. It is less than two weeks since this gentleman lost a barn, which, with its contents, cost \$4 000. Much valuable wood and timber is being burned at Lower Brighton, whence comes the village's greatest supply of wood and where most of the lumber sawn at J. K. Flemming's mill is cut. Many people in the village had purchased of the N. B. R. Co., which holds large areas in the region, wood lots which they have been jealously preserving for future use. These have all been burned over and made unfit for use. The fire in this instance was started by a fishing party.

It is said that Mr. J. K. Flemming intends going to Montreal for medical treatment by advice of the local physician.

The Primitive Baptist denomination will hold its annual conference at Hartland, beginning on the first Saturday in July and continuing over until Wednesday.

Forest fires that were started by a careless fisherman in the Deep Creek gulch burned fiercely all last week. Much timber and wood land destroyed the barn on the rear of D. H. Nixon's farm. Mr. Nixon lost his other barn by fire only a few days previously. It almost seems there should be a close season on matches.

W. R. Gillin shipped a carload of hogs to Montreal, on Saturday, May 22nd. Mr. Gillin also went to Montreal, returning on Wednesday.

Ubalde Michaud Tried to Break Jail at Edmunston.

Ubalde Michaud, who is in jail in Edmunston on the charge of attempting to wreck trains on the Temiscouata Railway, made an unsuccessful attempt to break jail. The prisoner in some way obtained possession of a piece of sheet iron which with a considerable degree of skill he filed into a rough saw. With this implement he made a determined attempt to get out of his cell, but was discovered in time.

For some time beginning about March 20, the Temiscouata Railway trains have frequently been interrupted on their tracks between St. Hilaire and Baker Brook. These interruptions became so frequent and the danger to property and life became so acute that the management decided to have an investigation made. Consequently the Thiel Detective Agency of Montreal was given charge of the case and on May 4th started working. On the night of May 20, Inspector Little and Detective Bresset, of the above service, arrested Ubalde Michaud and Paul Michaud, his son, of Baker Brook, charging them with attempting to wreck an express train of the company.

A search was made of their house and some dynamite and iron made to fit the rail-joints were found. On the night of May 21, a water tank at Caron Brook was blown up by dynamite and the mixed train was held up owing to iron wired down on the track.

When the case was called on Thursday, May 27, the suspects were not present. Their bail was forfeited and the officers located them at Fort Kent, Me., that night bringing them back at once. They were arraigned on Saturday morning. On Sunday the son made a confession, implicating his father.

That the elder Michaud had made threats against the company was well known among his neighbors, about twenty five of whom have been called as witnesses.

Preliminary hearing of charge preferred against Ubalde Michaud and his fourteen-old-son, Paul Michaud, accused of attempting to wreck a night express from Edmunston on the Temiscouata Railway and also attempting to dynamite the station at Clair, Madawaska county, opposite Fort Kent, Me., was resumed here this morning before Hector Nadeau, Stipendiary Magistrate.

Paul Michaud was the only witness examined in the morning. He stated that his father had given him pieces of iron, instructing him to insert them in the rails, which he did, but the iron was discovered there before the train had passed.

At the afternoon session, Helena Michaud, sister of Paul, and daughter of Ward, testified to the effect that she had heard her father making threats against the railway. Witness sent her brother, Paul, to remove rocks, which she had seen a man placing on the track. Witness did not know the man and could not state whether it was her father or not. The hearing will be resumed today and will not be finished for about three days as there are quite a few more witnesses to be examined. Young Michaud feels his position keenly, and much sympathy is being expressed here for him. There is a possibility of his being released from jail.
