The Roosevelts Sail Away

Former President Roosevelt, Mrs. Roosevelt, Kermit, and Miss Ethel sailed for Naples March 30, on the steamer Prinz Heinrich.

On the Roosevelts arriving at Rome on the 3rd inst., it was made known, the ex-President was refused an interview with the Pontiff. It appears His Holiness would have been pleased to have granted an audience to the American provided

the ex-Vice-President Fairbanks incident at the Methodist mission in Rome should not be repeated. This restriction was not acceptable to Mr. Roosevelt, who felt that in the end, as he puts it, "he must decline to make any stipulations or submit to any conditions, which in any way, would limit my freedom of conduct."

The American statesman has sent a long telegram to the New York Outlook expressing his regret that he was unable to pay his respects to the Head of the Roman Catholic church, protesting that among her members are many of his warmest friends, and affirming his great admiration for the achievements of Catholic missions which he had seen in Africa. The entire communication almost in every line, shows the Ex-President's personal humiliation over the unfortunate affair, as well as a dread of becoming involved in an acrimonious controversy.
