Say the Czarina Tried to Suicide

Berlin, Nov. 30.—Code dispatche received to-day from St. Petersburg says that the Czarina attempted to commit suicide on Wednesday after being informed by court physicians that there was no hope for the complete recovery of Grand Duke Alexis, the young Czarevitz.

The condition of the Czarina's health has been steadily growing worse since her son was stricken. No details of the manner in which she tried to end her life are given in the despatches.

An Alberta Blaze.

Calgary, Alta., Nov. 29.—A run of 21 miles over the frozen prairie roads to Langdon by the Calgary Motor Fire Apparatus, saved the business section of that town from destruction yesterday afternoon.
