

# BURGLARY IN TOWN.


Oldenburg's general store was broken into Wednesday night by burglars and about \$100 worth of cloth-ing and groceries stolen. They also took about \$7 in cash.

Becker Is Guilty of Rosenthal Mupdep

New York, Oct. 24.-Police Lieut. Charles Becker was found guilty Thursday night of mui der in the first degree for instigating the death of Herman Rosenthal, the gambler. Becker was remanded for sentence to the Tombs by Justice Goff until Oct.

Becker did not flinch when he heard the verdict, but Mrs. Becker, sitting outside the door of the courtroom, fell in a swoon.

John F. McIntyre, Becker's chief counsel, announced that he would take an immediate appeal.

The twelve jurors with solemn faces and measured steps, left the court room at 2.20 o'clock, and returned at 11.55 o'clock. A minute later the defendant was brought in from the Tombs. Justice Goff arrived at 11.58 and bowing low to counsel, took his seat. The jury roll was called. The clerk then asked the jurors if they had reached a verdict.

"We have," announced Foreman Skinner. The jury rose to its feet.

"We find the defendant guilty as charged in the indictment," Mr. Skinner said, slowly and evenly, looking squarely at Justice Goff.

"Do you find the defendant guilty of murder in the first degree as charged in the indictment?" asked the clerk.

"We do, " the foreman replied. The court then directed that the roll of the jurors be called for their ndividual verdicts.
