Mr. Joseph McCready

As previously announced in our columns, Mr. Joseph McCready of Jacksonville passed away at his residence on Monday April 8th., at 8 o'clock in the evening.

He was a citizen of highly respected character and had always been prominent in any good work of the neighbourhood. It is about 30 years since Mr. McCready came to Jacksonville from Avondale and most of that time he has been a member and deacon of the Baptist Church, one of its ardent supporters and chief counsellors. He was also for many years superintendent of the Sunday School.

At his own request the funeral was a quiet one, and a memorial service was held the following Sunday.

The funeral took place on Thursday 11th., and was conducted by the Revs. W. H. Johnson and Geo. Ayers. A large number of neighbours gathered at the house to witness the simple ceremony Mr. Jas. Watson led the singing of "Rock of Ages" and after prayer and scripture reading, Rev. W. H. Johnson spoke a few words upon the text:—"There shall be no more sea"

A number of floral tributes had been sent to the house,—Among them being gifts from Dr. Kierstead, Mrs. C. T. Phillips and a wreath of roses and lilies from members and friends of the Baptist Church. The remains were interred at Jacksonville.

On Sunday April 14th. a memorial service was held at Jacksonville Baptist Church where a large congregation gathered.

The hymns "Forever with the Lord"; "It is not death to die"; "We speak of the realms of the blest" and "Give me the wings of faith to rise", were sung,—The choir rendered "For all the saints who from their labours rest" and Miss E. M. Hayward sang "Oh the peace my Saviour gives", as a solo.

The sermon was upon the text, Heb. 11:4, "Through it he being dead yet speaketh. In speaking of the message of the life of the departed the preacher said:—"He speaks of a realization of Sin; of Faith; of Obedience and of Service"

Mr. McCready is survived by his wife, his two daughters Mrs. Olmstead, of Wicklow, and Mrs. Lewis, of Portland, Oregon, his son William R. of Vancouver B. C. and his two brothers of Houlton, Me., and St. Stephen N. B.
