In noting the change of date of Concert of the new Choral Society from May 23rd., to the 21st., we are able to say something of the fine Program which is promised. Several of the choruses are different in kind from anything that Woodstock has ever heard, excepting some of the older people or those who have visited the larger cities, "The Heavens are Telling," by Haydn, from the "Creation" oratorio; The "Gloria" by mozart, in the Latin, are among these. The new band master, Mr. F. B. Herrick, and his son Ralph Herrick will also take part supplying orchestral accompaniment to the voices. Mr. Herrick, Senior, before coming to Woodstock was for many years orchestrai and band leader in permanent organizations in the United States and is a splendid performer on the violin, E-flat Cornet, and double-bass strings, as well as a trained conductor. His son who is talented, and is also a trained band leader, is a cornet Soloist, and will make his debut to a Woodstock audence in this Concert playing, the "Inflammatus" from "Stabat Mater" of Rossini. We may say that this is not only a very difficult but one of the grandest pieces of music, and it will be well worth going to the Concert to hear this alone. We understand Mr. Herrick intends to take private pupils on the violin and that such arrangement has been made with Mrs. Adney as is the equivalent of a violin and orchestral instrument branch of the Woodstock School of music, thus widening its scope as was intended when opportunity offered.
