been contracted outside that village. We have been allowing the question of pure water to siide along, but it is a serious matter when typhoid touches our own family. It might be diffi :ult to finance a new water system but the measure requires immediate action. There was no doubt in his mind but that all past epidemics of typhoid were caused by the river water.

Dr. N. P. Grant said that he endorsled the remarks of the other speakers. Queen St.,

There was never a Joubt in the minds of the doctors but that the source of typhoid was the river water; the fever did not come from the milk or sewage, consequently by elimination the fever. is due to water. He had traced the origin of some of the cases from the country, and he believed they came from the town water. It is unfortunate that we must continue to use water that is contaminated. The ratepayers would be satisfied to spend the money for pure water, even if they did without other necessary town improve-

Couns Young and Flemming spoke to the question, arguing that we needed, probably, a pure water system, that it would cost \$10,000 and the money was not in sight.

Coun Leighton-Give me the delinquent taxes for 1914 and previous years and I will agree to prospect for pure water and only spend the money as it is collected from 1914 taxes and the years before.

Coun Noddin-We are not against pure water. We made an appropriation of \$500 to go toward that object, without a dissenting voice, and Coun Leighton is asking for more money before he has spent that amount.

Mayor Sutton then thanked the doc tors for their attendance and they left the meeting.

Moved by Coun Leighton that the matter of the appointment of a super intendent of the water works be laid over till next meeting. Carried. Coun Flemming reported that the owner of the property on Connell street

drained to the creek, demanded that the sewer boxing be removed and the excavation filled. Referred. Voted that the water committee be given power to make the necessary

year's account. Carried. Coun Leighton asked if the Council was aware that one of the C. P. R. gatemen, Geo Chase had been dismissed by the railway examiners, on the color test, and that Lawson Fisher had been appointed in his stead. He wanted to know if the Ccuncil had been consulted in the matter.

Mr. Hartley, the clerk said that the Mrs. Ernest Burtt who has day at Mrs. Wm. McWaid's, quite a former gatemen had been approved 'y the Council and appointed by the C. P. R. The change was made without the Council being consulted.

Coun Flemming was given permission to repair the sidewalks in town, lay new road from the C. P. R. station south as far as the crushed rock would go, and, besides the four now under construction, build other crossings provided he would keep under his appropriation.

Coun Leighton brought up the question of the sale of property of defaulting taxpayers, which had not been closed to his satisfaction, and promised to again refer to the matter at next meeting.

Voted that the salaries falling due be ordered paid. Voted to adjourn till Monday evening, Aug 23.
