Now, therefore, be it resolved that this Council memorialize the Local Government to pass Legislation fix ing a standard width for double team winter roads in the Province so that sleds would have to be built of a stan dard width of 4 ft. 4 ins, in order to prevent the difficulties which now proved by reason of the roads being


