Havre, France, March 9 .- General Von Bissing, Governor General of Relgium, has issued a decree ordering the seizure throughout Belgium of certain articles for removal to Germany when the quantities held by any owner exceed certain specified numbers or weights.

There are 60 articles on the list, including tablecloths, napkins, silks, manufactured or raw; waterproof stuffs and garments, olcloths, woolen yarns, fibres of every sort, animal hair, bristles, feit, old or new blankets, tarpaulin, leggins, knee bandages and other sani tary articles.
