The latter was captured, but Perry, in spite of various shots fired at him by the guards, persisted, and was finally shot dead, the bullet entering his back on the left side, passing through to the right and killing him instantly. Perry who was but seventeen years old, was one of the trio, John Rogers and Hugh Olney being the others, who on the night of Dominion Day, 1881, assaulted Mr. Chip Smith, of Shediac, at Sussex, and robbed, and attempted to rob him of his watch and money. Mr. Smith was severely wounded by the young ruffians, who had gone up to Camp Sussex from St. John, and the crime was such an aggravated one that at the instance of King's Circuit Court, Rogers and Perry were sentenced to life imprisonment for seven years in the Penitentiary.
