

Shocking Murder.


Intelligence of a shocking murder comes from a place called New River in Charlotte County. The murdered man's name was Thos. Ward. His body was found partially eaten by insects where it had been unperfectly buried in moss, etc., in bushes some 200 yards from his house. The crime was, doubtless, committed on the 9th Sept. that being the day on which deceased was last seen alive. A man named Thos. Dowd is supposed to be the murderer. It is also thought Ward's wife assisted him and that the cause of the crime was previous criminal intimacy between the two. Ward was a farm laborer and lived with the Wards. Another farm laborer named McCarthy, who, for being too intimate with Ward's daughter, was turned out of the house by Ward on Saturday, 7th Sept., is also suspected of

having had a hand in the crime. Death was caused by some blunt instrument by which the skull was broken in. It is supposed that Ward was waylaid and murder. ed while on his way to meadows not far from his home. The inquest was in progress at last accounts.


